SUPERIOR COURT OF THE DISTRICT OF COLUMBIA ADMINISTRATIVE ORDER 11–11 Amended

Appointment of Attorneys to the Criminal Justice Act Panel – July 18, 2011

WHEREAS, Administrative Order 10-2, issued on January 15, 2010, reconstituted the Criminal Justice Act Panel ("CJA Panel") of attorneys and directed the CJA Panel Implementation Committee to receive and evaluate applications at any time, during the time between the periodic re-establishment of the Panels; and

WHEREAS, the CJA Panel Implementation Committee has considered applications filed on or before February 15, 2011, from new and previously-considered attorneys, from Provisional Panel Members seeking to be appointed as Full Panel Members, and from Full Panel Members appointed for a term of one year seeking to extend their terms; and

WHEREAS, the CJA Panel Implementation Committee submitted its Report to the Chief Judge recommending additional attorneys to be appointed to the CJA Panel as Full, Provisional, or Conditional Members; and

WHEREAS, the Chief Judge is satisfied that the recommendations of the CJA Panel Implementation Committee with respect to the attorneys to be placed on the CJA Panel have been made after careful study and consideration of each attorney eligible to be considered and should be accepted in their entirety without change;

NOW, THEREFORE, it is by the Court,

ORDERED, that the attached list of attorneys shall be CJA Panel from this day forward, and attorneys listed are appointed as Full, Conditional, or Provisional Members as set forth in the attached list; it is further

ORDERED, that absent suspension or removal, and except as otherwise stated hereafter, the attorneys listed as Full Members are appointed to the CJA Panel until the re-establishment of the CJA Panel, at which time they must submit an application for reappointment, pending the determination of which they may remain CJA Panel members; it is further

ORDERED, that the attorneys whose names appear on the list of Conditional Members are not eligible to accept appointments, but may become Full Members of the Panel, if within nine (9) months from the date of this Order, they notify the Chairperson of the CJA Panel Implementation Committee that (1) they are presently available to accept appointments, (2) they are still members in good standing of the Bar, and (3) no disciplinary action or investigation has been instituted against them since the filing of the application. Attorneys who fail to make such notification within nine (9) months of the date of their conditional appointment are no longer eligible to become members of the Panel based on their conditional membership; it is further

ORDERED, that the attorneys whose names appear on the list of Provisional Members shall be eligible to accept appointment in misdemeanor cases only for a period of two (2) years, unless shortened as hereafter described, at which time they must apply to become Full Members of the Panel for the remaining years of the term of the Panel, provided, however, that to become

a Full Member, Provisional Members should represent a defendant in at least two felony trials (including jury selection), as a second chair; it is further

ORDERED, that any Provisional Attorney may apply to be appointed as a Full Member prior to the expiration of the two-year term provided that (1) the attorney represents a defendant in at least two felony jury trials (including jury selection), as a second chair, and (2) the CJA Panel Advisory Committee recommends the attorney for early appointment as Full Member; it is further

ORDERED, that an attorney's membership on the Panel is conditioned upon his or her compliance with all Administrative Orders setting an annual cap for attorney compensation for appointed representation and providing representation in conformance with the Attorney Practice Standards for Criminal Defense Representation previously published; it is further

ORDERED, that any eligible attorney who filed an application prior to February 15, 2011, and who was not appointed to the Panel must wait at least eighteen (18) months from the date of this Order to reapply; and it is further

ORDERED, that this Order shall take effect on July 18, 2011.
