ORDER GRANTING PLAINTIFF'S MOTION FOR ALTERNATIVE SERVICE BY POSTING

This matter is before the Court upon consideration of Plaintiff Marta Lidia Zuniga
Vasquez's ("Plaintiff") Motion for Alternative Service by Posting, filed on March 14, 2024.
The instant case involves a Complaint for Custody for one Minor Child. Plaintiff has filed a
motion providing the details of her diligent search for Defendant Juan Carlos Amaya
("Defendant"), whose whereabouts in Honduras are unknown. The court will not repeat those
details herein. The Court is satisfied that Plaintiff has made a diligent investigation of
Defendant's whereabouts for purposes of ordinary service of process. The search was not
successful. Furthermore, Plaintiff has given an adequate explanation of why she should be
allowed to serve Defendant by posting in the Domestic Relations Branch Clerk's office and on
the Court's website at https://dccourts.gov/services/serve-notice rather than by publication in a
newspaper. The reason is economic.

ORDERED that Plaintiff's Motion for Alternative Service by Posting on Defendant is hereby **GRANTED**; and it is

FURTHER ORDERED that Plaintiff may serve Defendant, the father of the Minor Child, A.A.Z.V. (DOB: 11/02/2013) by posting on the Superior Court for the District of

Columbia's website for a period of twenty-one (21) calendar days and in the Domestic Relations Clerk's Office, starting with the date of this order; and it is

FURTHER ORDERED that if Defendant does not file responsive pleadings within twenty-one (21) days after service pursuant to the Rules Governing Domestic Relations

Proceedings, Rule 12(a), Plaintiff may file a motion for default and the Court may enter default by order and may convert the next hearing into a default/ex parte hearing to take testimony from Plaintiff and file a final judgment without Defendant's participation, and it is

FURTHER ORDERED, that if Plaintiff is seeking a default judgment, prior to the next scheduling hearing, Plaintiff shall file an Affidavit in Compliance with the Servicemembers Civil Relief Act; and it is

FURTHER ORDERED that a hearing on Plaintiff's Motion is scheduled for **September 5, 2024, at 2:00 p.m.** before Magistrate Judge Julie R. Breslow remotely on WebEx 99. Instructions on how to appear remotely are attached to this order; and it is

SO ORDERED.
