## **ORDER GRANTING MOTION FOR SERVVICE BY POSTING ON WEBSITE**

This Court is in receipt of Plaintiff's Motion for Leave to Serve Defendant by Publication, filed on February 15, 2020. Following the filing of this motion, the Court requested an amended affidavit in support of the motion. The SIJS Evidentiary hearing was scheduled for May 28, 2020, but was not held due to the outstanding service issues in this matter. On May 21, 2020, Plaintiff filed a second Motion for Leave to Serve Defendant by Publication, with an amended affidavit. The amended affidavit details Plaintiff's efforts to locate and serve the Defendant with the pleadings and notice for this matter.

The Court will grant the Plaintiff's request for alternative service, but in the form of posting on the Court's website rather than publication. In consideration of the entire record in the abovecaptioned matter, it is hereby

**ORDERED**, that service for this matter shall be completed by posting on the Court's website; it is further

**ORDERED**, that this Order shall be posted by the Clerk's office on the Court's website for a period of twenty-one calendar days; it is further

**ORDERED**, that should Defendant fail to enter an appearance in this matter within forty calendar days occurring after the first date of posting, the cause will be proceeded with as in Default; **PROVIDED HOWEVER** that Plaintiff files an Affidavit in Support of Default and Compliance with Servicemembers Civil Relief Act of 2003 with the Central Intake Center of the Family Court within that time; and it is further

**ORDERED**, that a Default/*Ex Parte* Custody and SIJS Hearing is set for August 27, 2020 at 2:00 pm. The hearing will take place remotely through the use of Webex technology. Parties will be provided instructions prior to the scheduled proceeding.
