ORDER GRANTING PLAINTIFF'S MOTION FOR ALTERNATIVE SERVICE BY POSTING ON THE PUTATIVE FATHER AND LEGAL FATHER

This matter is before the Court upon consideration of Plaintiff Sendy Stefanie Sasco Sanchez ("Plaintiff") Motion for Alternative Service by Posting on Defendant Miguel Julian¹ ("Defendant Putative Father") and Defendant Wayner Martinez Perdomo² ("Defendant Legal Father") filed on April 3, 2024. The instant case involves a Complaint for Custody for one Minor Child. Plaintiff has filed a motion providing the details of her diligent search for both the Minor Child's putative father and legal father, whose whereabouts are unknown. The court will not repeat those details herein. The Court is satisfied that Plaintiff has made a diligent investigation of both Defendants whereabouts for purposes of ordinary service of process. The search was not successful. Furthermore, Plaintiff has given an adequate explanation of why she should be allowed to serve Defendants Miguel Julian and Wayner Martinez Perdomo through

² Defendant Wayner Martinez Perdomo is listed as the Minor Child's father on his birth certificate and therefore, is her legal father.

posting in the Clerk's office or on the Court's website at <u>https://dccourts.gov/services/serve-</u> notice rather than by publication in a newspaper. The reason is economic.

ORDERED that Plaintiffs Motion for Alterative Service by Posting is hereby **GRANTED**; and it is

FURTHER ORDERED that Plaintiff may serve Defendant Miguel Julian, the putative father of the Minor Child, D.A.M.S. (D.O.B. 6/22/2006) by posting on the Superior Court for the District of Columbia's website for a period of twenty-one (21) calendar days and in the Domestic Relations Clerk's Office, starting with the date of this order; and it is

FURTHER ORDERED that Plaintiff may serve Defendant Wayner Martinez Perdomo, the legal father of the Minor Child, D.A.M.S. (D.O.B. 6/22/2006) by posting on the Superior Court for the District of Columbia's website for a period of twenty-one (21) calendar days and in the Domestic Relations Clerk's Office, starting with the date of this order; and it is

FURTHER ORDERED that if Defendant Miguel Julian and/or Defendant Wayner Martinez Perdomo does not file a responsive pleading within twenty-one (21) days after service pursuant to the Rules Governing Domestic Relations Proceedings, Rule 12(a), Plaintiff may file a motion for default and the Court may enter default by order and may convert the next hearing into a default/*ex parte* hearing to take testimony from Plaintiff and file a final judgment without Defendant Miguel Julian's and/or Defendant Wayner Martinez Perdomo's participation, and it is

FURTHER ORDERED, that if Plaintiff is seeking a default judgment, prior to the next scheduling hearing, Plaintiff shall file an Affidavit in Compliance with the Servicemembers Civil Relief Act; and it is
