1. L.22.3 states offerors are to “provide a minimum of five (5) program past performance examples the offeror has been involved in within the last ten (10) years.” As a business, we are a new entity with very limited past performance, but the business consists of a team of individuals with extensive experience in this field. With that said, in lieu of corporate experience will you accept the experience of key personnel within the organization, and will that experience be given equal weight? **Experience of key personnel will be acceptable, however will not be given equal weight.**
2. Can a Contractor Performance Assessment Report (CPAR) substitute for a PPQ? **Yes**
3. On page 34, section F5.3.3, the RFP states that Construction Managers are required to have a MINIMUM of 15 years of experience, would DC Courts consider accepting a PgMO Construction Manager with 10 years of experience? **No**
