

DELETE: Section M.1 Evaluation for Award, Page 60, Paragraph 4: "Upon evaluation of written proposals, the Courts may invite a short list of Offerors to demonstrate their solutions. However, the Courts reserve the right to proceed to negotiations with the highest scoring Offeror at the end of Phase 1. The Courts may also award a contract upon the basis of initial offers received, without discussions. Therefore, initial offers should contain the Offeror's best terms from a cost and technical standpoint."

INSERT: Section M.1 Evaluation for Award, Page 60, Paragraph 4: "Upon evaluation of written proposals, the Courts may invite **contractors who score in the competitive range to demonstrate their solutions**. However, the Courts reserve the right to proceed to negotiations with the highest scoring Offeror at the end of Phase 1. The Courts may also award a contract upon the basis of initial offers received, without discussions. Therefore, initial offers should contain the Offeror's best terms from a cost and technical standpoint."
