#### SOLICITATION QUESTIONS & ANSWERS: ROUND 01

- Q.1 Per RFP documents (011000 1.10) please confirm the on-site work hours are 6:00pm to 6:00am or are these hours only for noisy activities? Note (3) states the hours for Core Drilling as off-hours or weekends, but then I think the normal business hours shall be 6:00am 6:00pm.
- A.1 Work may be performed during normal business hours 6:00am to 6:00pm. Noisy work and work requiring the primary equipment to be shut off shall be done after normal business hours.
- Q.2 Is Bell & Gossett the only approved pump manufacture or are there approved equals? There are no chilled water pump specifications to reference.
- A.2 Please see attached the Hydronic Pump specifications, including approved manufacturers. Please also see attached the Commissioning and Hydronic Piping specifications for this project.
- Q.3 Is Danfoss the only approved plate and frame heat exchanger manufacture or are there approved equals. There are no hx specifications to reference.
- A.3 Please see attached the Heat Exchanger specifications, including approved manufacturers.Please also see attached the Commissioning and Hydronic Piping specifications for this project.
- Q.4 Are multipurpose valves an approved alternate on the discharge side of the condenser water pumps rather than a butterfly, swing-check and strainer?
- A.4 Multipurpose valves are not acceptable.
- Q.5 The existing air separator has isolation valves before and after. Please confirm if the contractor shall install per previous design or only provide isolation on the discharge side of the air separator.
- A.5 Provide isolation valves before and after the referenced air separator.

- Q.6 Please confirm HVAC equipment shall have Aluminum, Stucco Embossed (0.032" thick) rather than PVC colored jacketing similar to the HVAC Piping Insulation.
- A.6 Confirmed.
- Q.7 Please provide a contact for the existing Direct-Digital Control (DDC) system.
- A.7 Albireo Energy Todd Jameson, 301-653-2722
- Q.8 Please confirm Automated Logic (Alberio Energy) is the sole source controls contractor for this project.
- A.8 Confirmed
- Q.9 Page 5 of project manual under 1.10 Work Restrictions B states working hours to be 6:00 pm 6:00 AM. Is this correct, please advise?
- A.9 Refer to Question #1 above.
- Q.10 There is a large Insulation specs that calls for insulation on condensing water pipe and pumps. There is no existing insulation on condenser water system, is this a requirement?
- A.10 Provide insulation as specified.
- Q.11 There is an allowance for hazardous materials of \$50,000 listed in the bid docs. Could you share where the anticipated hazardous materials are located?
- A.11 The Contractor shall perform a hazardous material survey to determine locations of hazardous materials.
- Q.12 Since there hasn't been any addendums and the bid is due the day after a long holiday weekend 9/6 we are asking the bid be extended one week to allow time to get pricing & answer the RFIs. Please advise.
- A.12 The bid date has been extended Friday, September 9, 2022, 3:00pm.
