ADMINISTRATIVE ORDER 01-33

The current system for the distribution of neglect and abuse cases is to bring all judges to 80 cases before assigning additional cases to the judges who already have more than 80 cases, and, thereafter, to maintain parity among the calendars by keeping track of closures and keeping each calendar at an equal number of cases.

Now, therefore, it is hereby

ORDERED that, as of this date, the assignment list and the number of cases to be assigned to each judge who does not yet have 80 cases, are as follows:
