As the GAL project director, he managed over half of CLC's 80 person staff which, together with hundreds of pro bono partners, helped more than 2,000 children and caregivers every year.

Judge Staples also previously worked as an assistant public defender in Fairfax, VA and as a sole practitioner. He tried dozens of cases in criminal and family courts. He is former co-chair of the Courts, Lawyers and Administration of Justice Steering Committee of the D.C. Bar and a member of D.C. Law Students in Court Board of Directors.
