## ORDER

On consideration of the certified order of the Supreme Court of Florida suspending respondent from the practice of law in the state of Florida for a period of one year; this court's February 28, 2018, order suspending respondent pending further action of the court and directing him to show cause why the functionally-equivalent reciprocal discipline of a one-year suspension with a fitness requirement should not be imposed; the statement of Disciplinary Counsel regarding reciprocal discipline; and it appearing that respondent failed to file a response to the court's show cause order or his D.C. Bar R. XI, §14 (g) affidavit, it is
