

**SUPERIOR COURT OF THE DISTRICT OF COLUMBIA  
ADMINISTRATIVE ORDER NO. 23-08**

**CJA Guideline Fees for Superior Court Cases  
Supersedes Administrative Order 09-05**

**WHEREAS**, pursuant to the 2023 Consolidated Appropriations Act, the hourly rate of compensation for legal services to indigent defendants performed under the Criminal Justice Act has been increased; and

**WHEREAS**, pursuant to Section II(D)(5)(a) of the CJA Plan, the committee responsible for recommending modifications to the schedule of applicable guideline fees has proposed increases in the fees;

**NOW, THEREFORE**, it is by the Court

**ORDERED**, that the Table of Guideline Fees for Superior Court Cases be and hereby is amended to read as follows, effective *nunc pro tunc* to January 1, 2023.



Driving while suspended	9.0	\$990
Driving while revoked	9.0	\$990
Driving while intoxicated or under the influence	9.0	\$990
Indecent exposure	9.0	\$990
Leaving the scene of an accident (property damage and/or personal injury)	9.0	\$990
Operating while impaired	9.0	\$990
