During 2021, the COVID19 pandemic continued to impact court operations at the D.C. Courts. In reaffirming its commitment to ensure access to justice and fair and timely case processing, the D.C. Courts continued innovative practices to enhance electronic filing procedures, expand the utilization of remote hearings, and realign dedicated resources to focus on case processing. Those efforts are reflected in this report as progress was reported in case processing for select case types compared to last year. The D.C. Courts anticipate continued improvements in access for court users and in overall case processing. Detailed information about the Courts' response to improving access and services to its users is available in its companion publication, 2021 Annual Report.

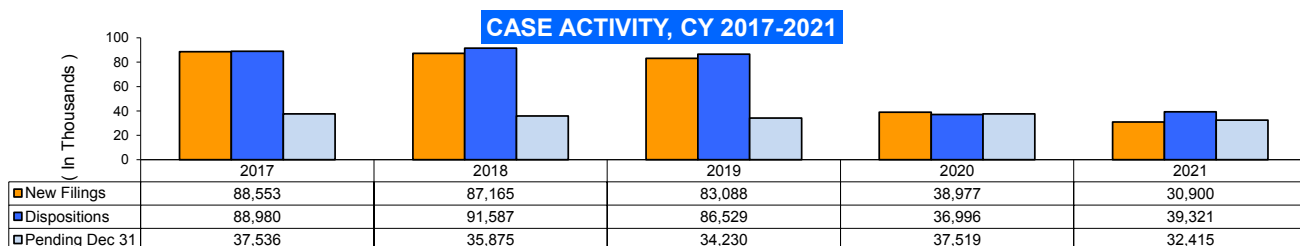

^dDue to recently enacted legislations, two new case types were added to the Division's caseload. The Firearms Omnibus Emergency Amendment Act of 2018, the Extreme Risk Protection order (EPO) can be filed by asking the court to remove firearms, ammunitions, certificates, licenses, and/or registrations from a person who poses a significant risk to themselves or others. In addition, the Anti Stalking Orders (ASO) Amendment Act of 2020 (Amendment Act) is a court order in which a judge can require a person to follow certain requirements, including but not limited to, staying away from, not contacting, or committing any offense against the person requesting the ASO.

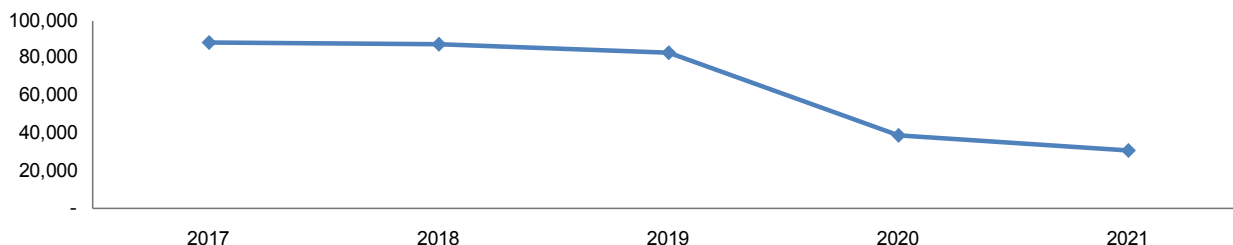

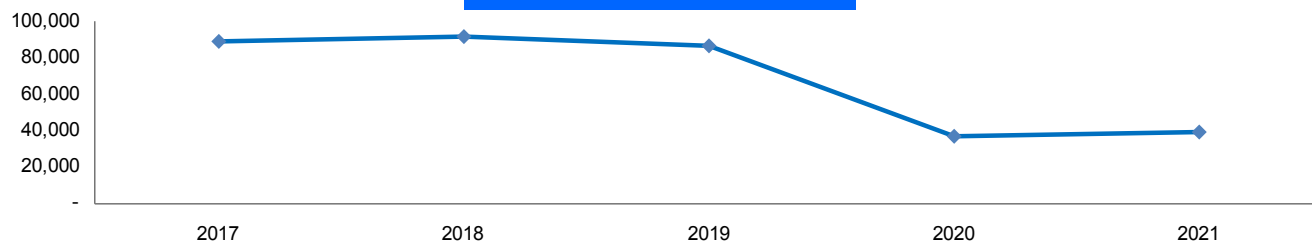
NEW CASE FILINGS TREND

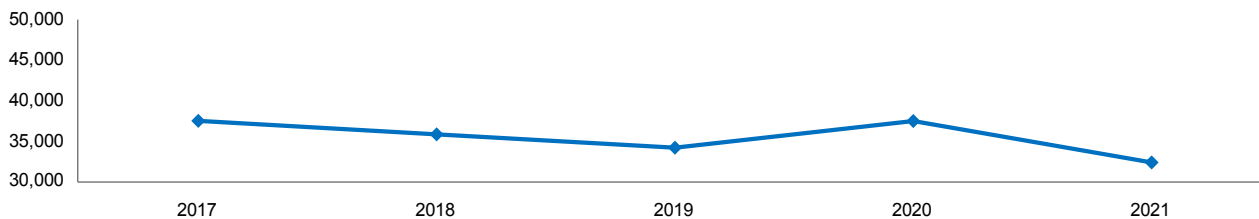

PENDING CASELOAD TREND

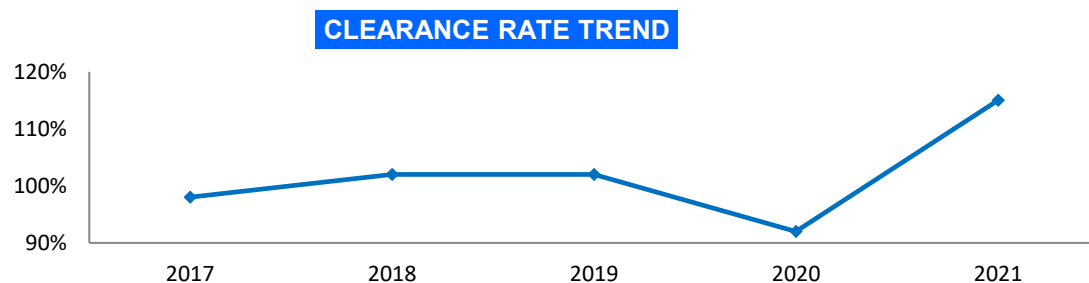

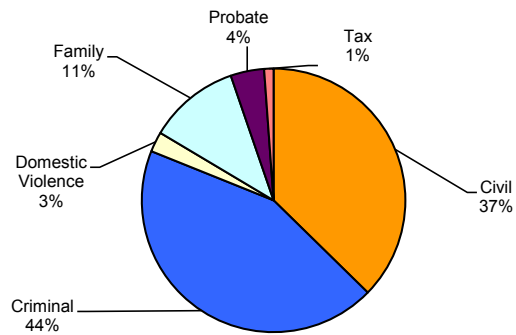

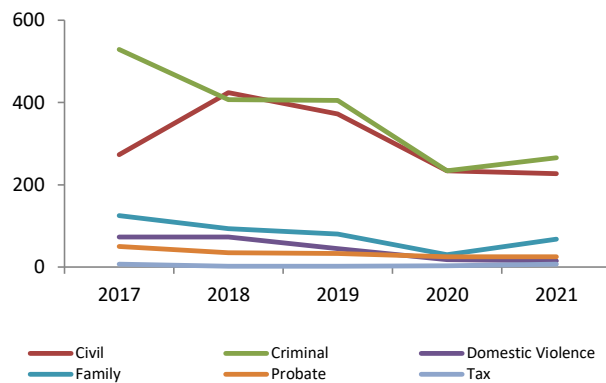

Trend in Appeals, CY2017-2021

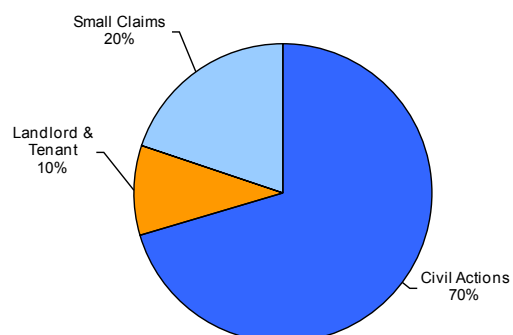

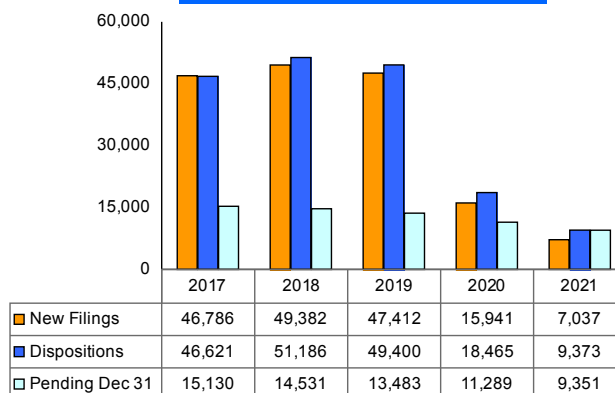

2021 New Case Filings (N=7,037)



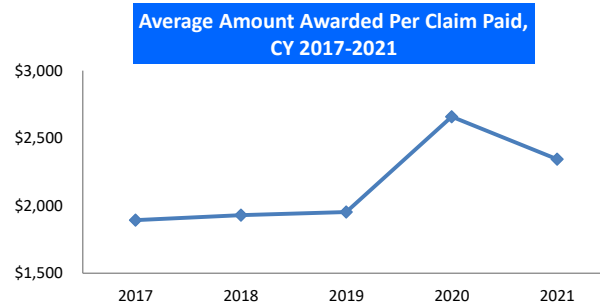
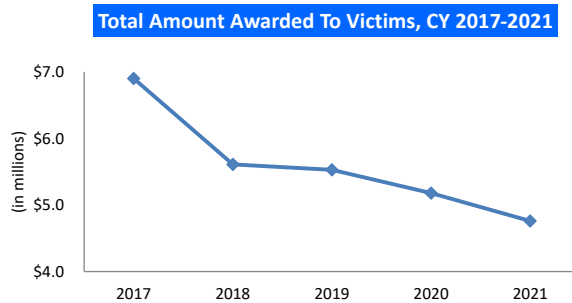
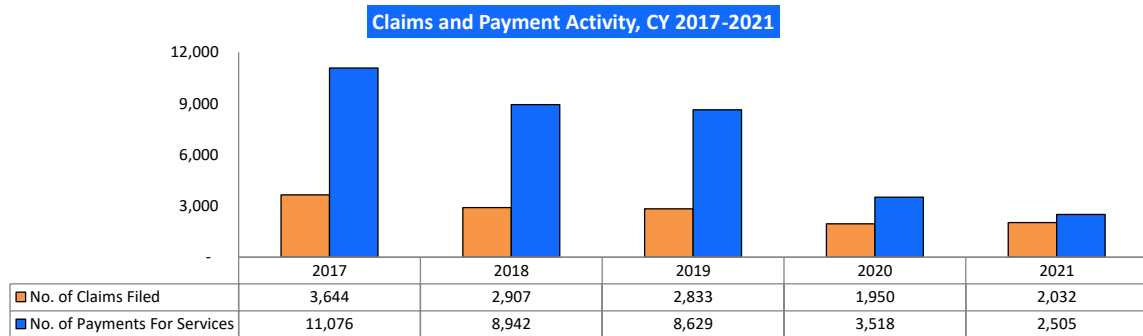

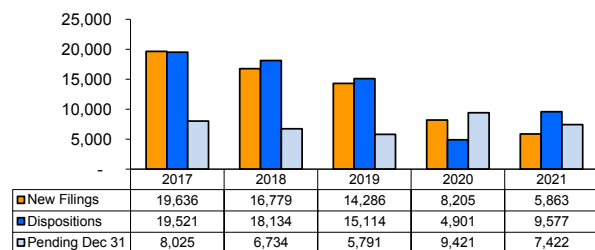

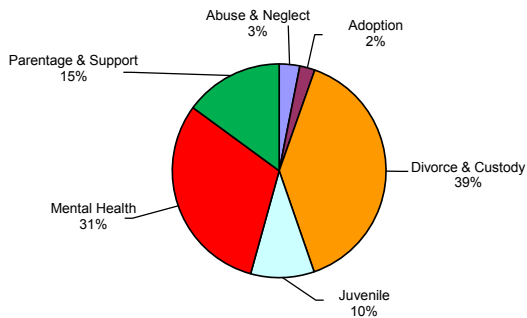

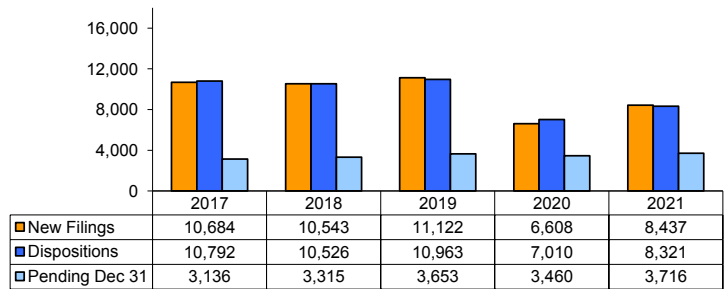

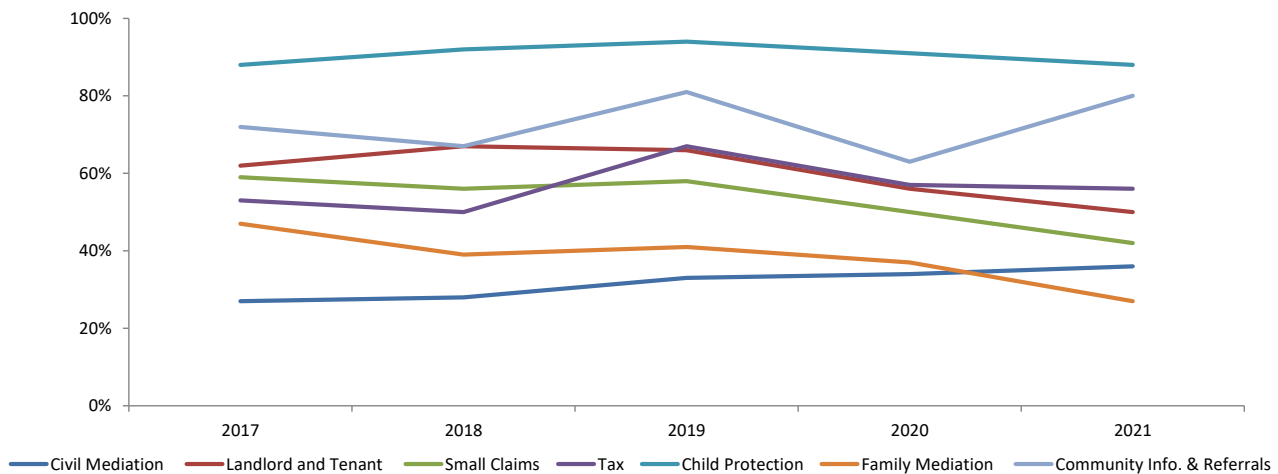

Settlement Rate of Select Mediation Case Types, CY 2017-2021



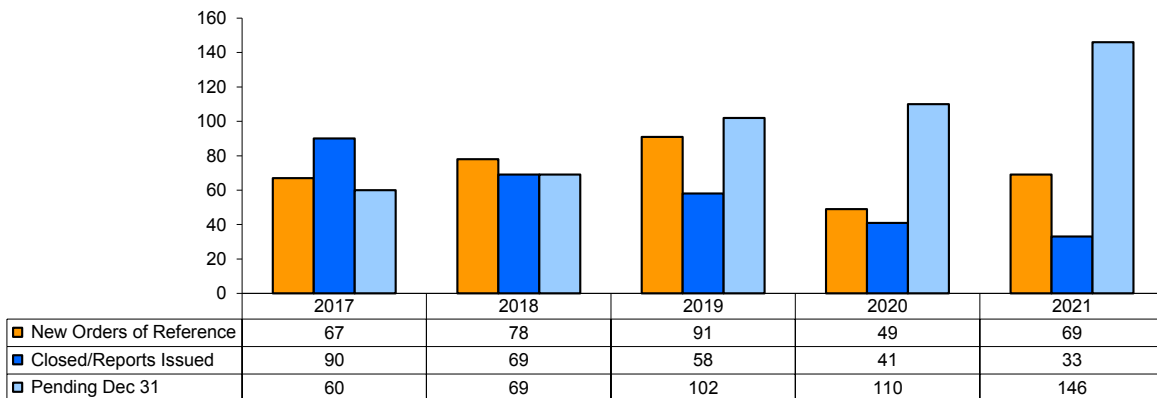

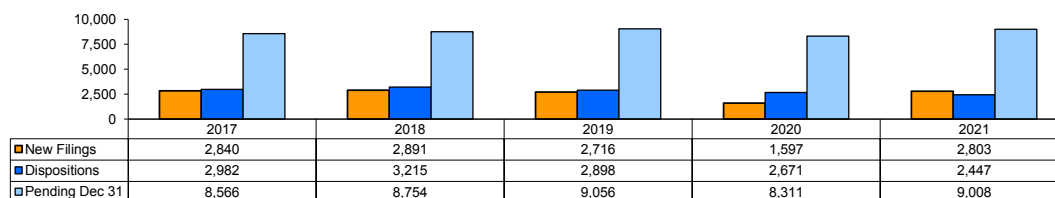

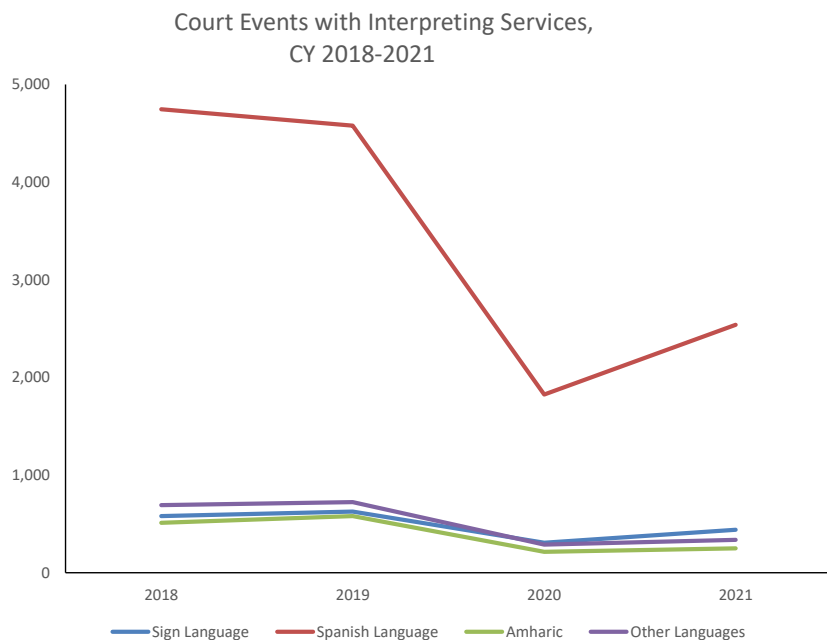

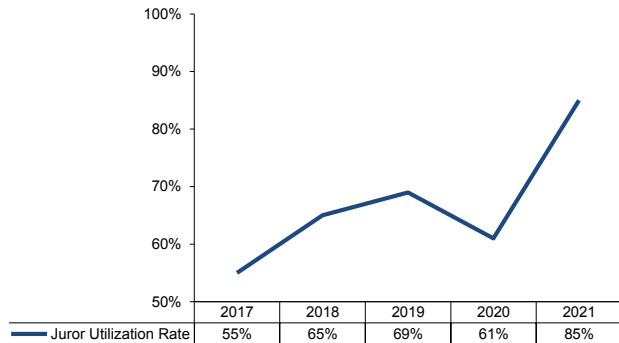
