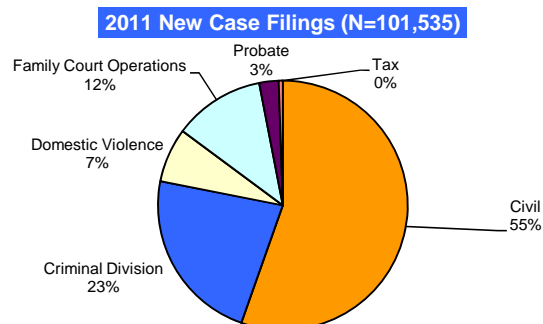

2011 New Case Filings (N=56,272)



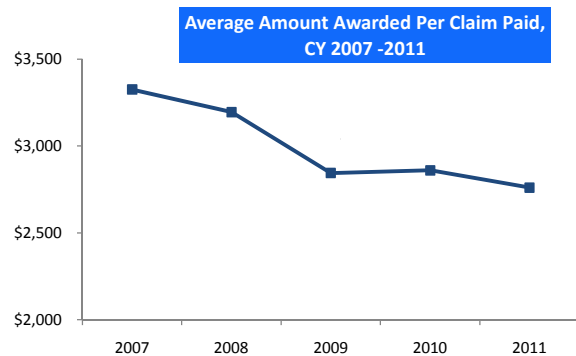
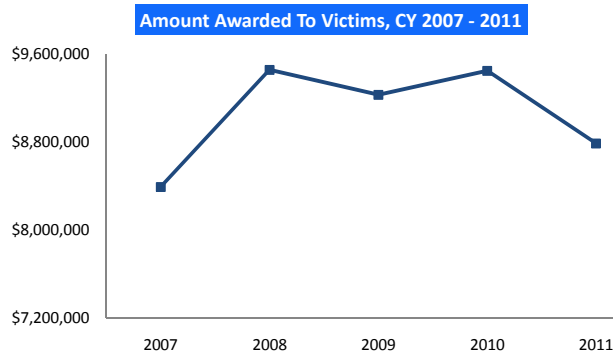
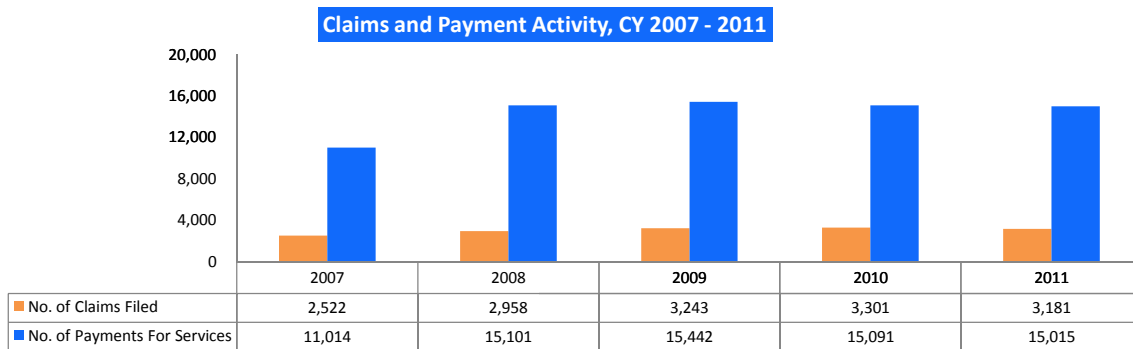

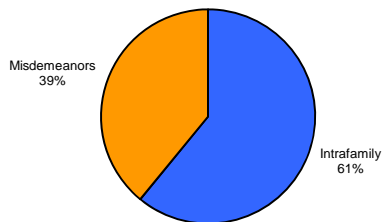

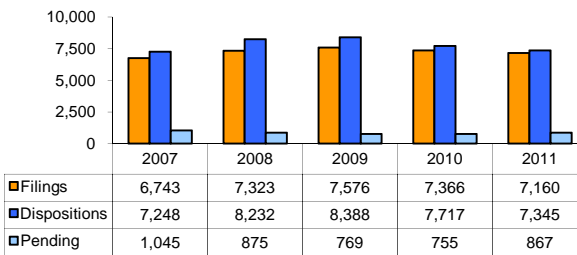

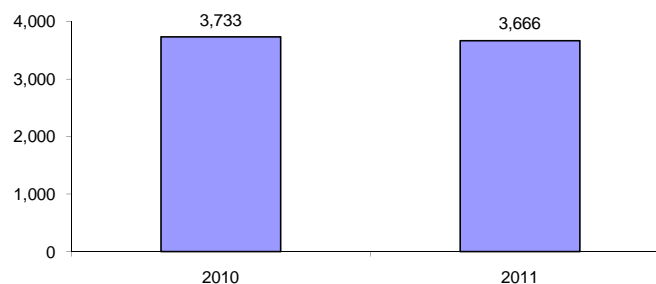

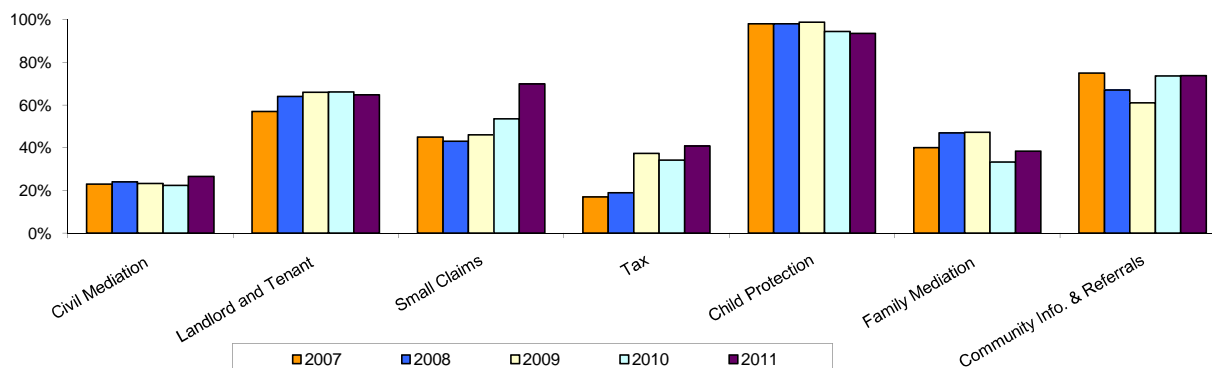

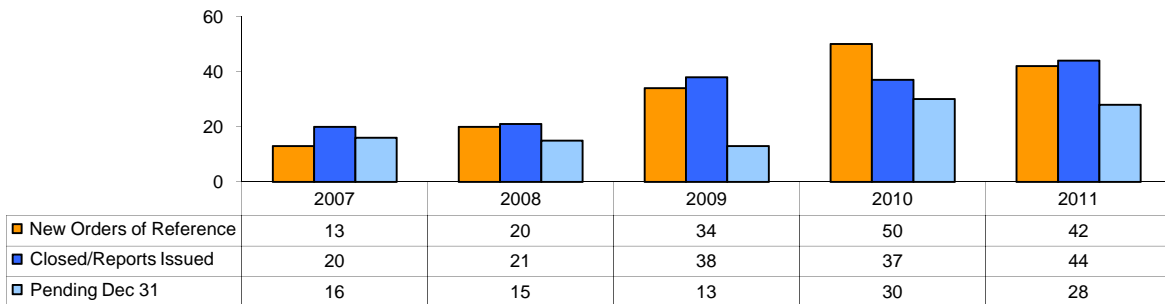

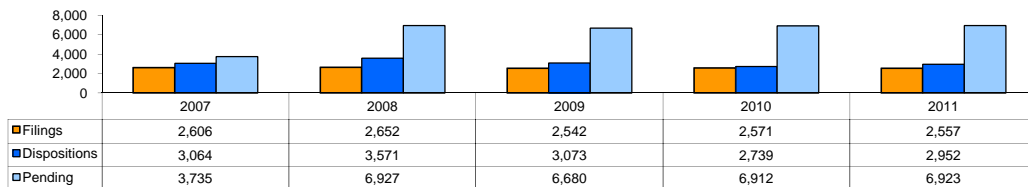

2011 New Case Filings (N=2,557)



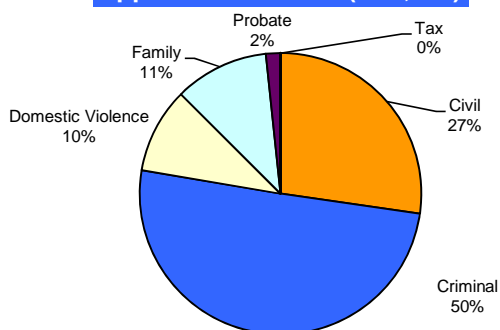

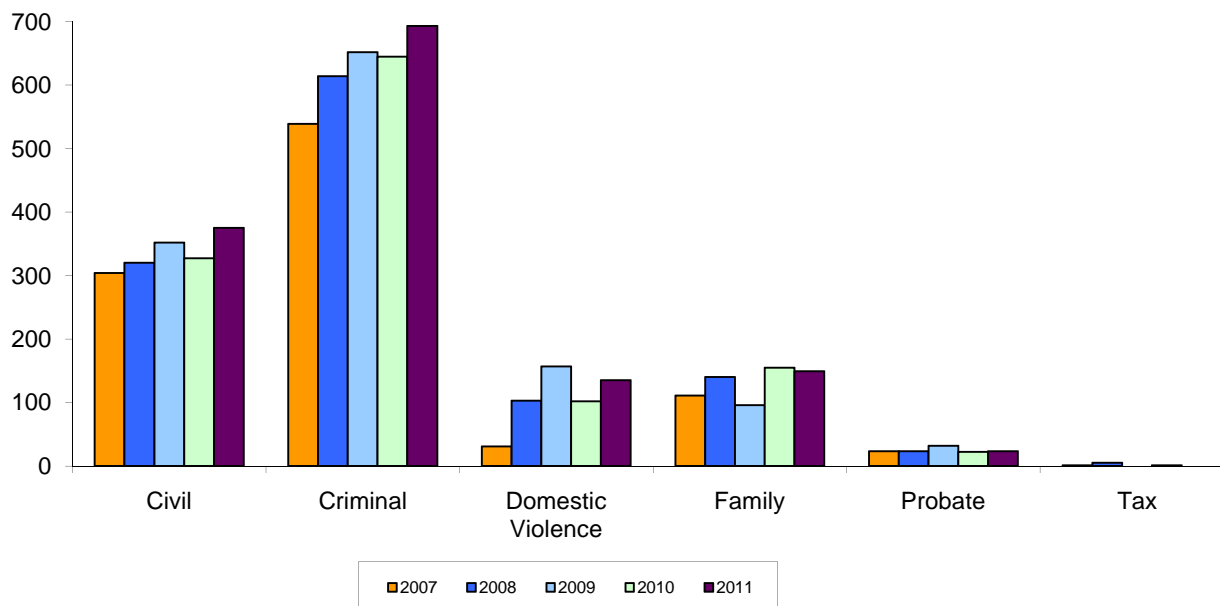

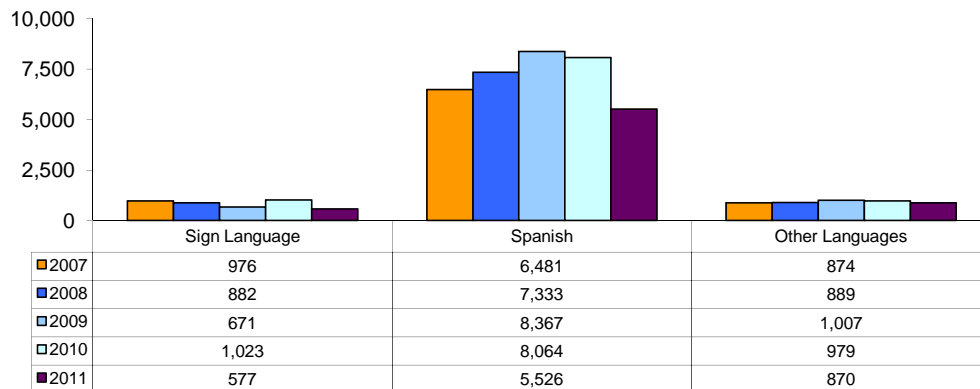

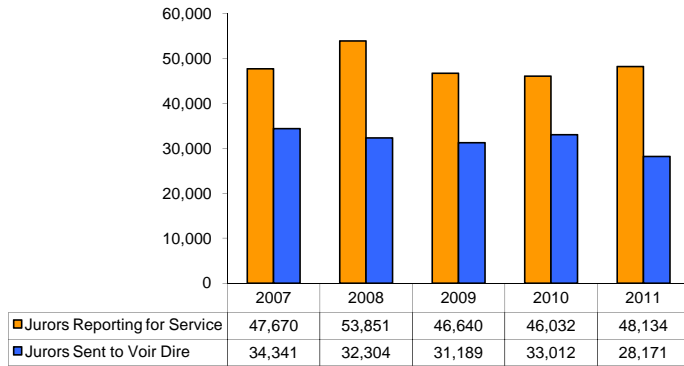

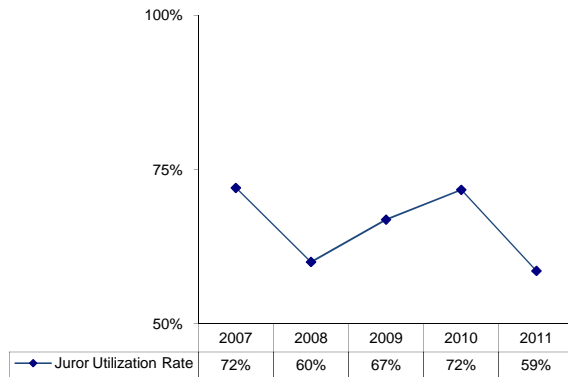

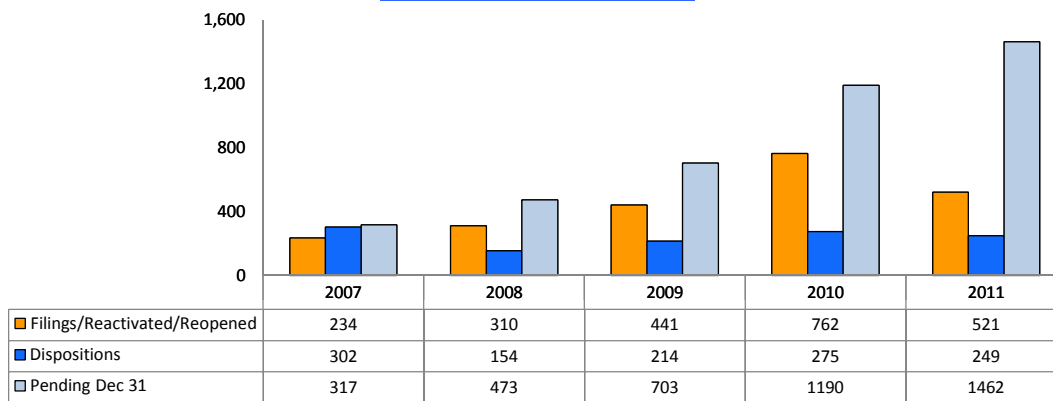

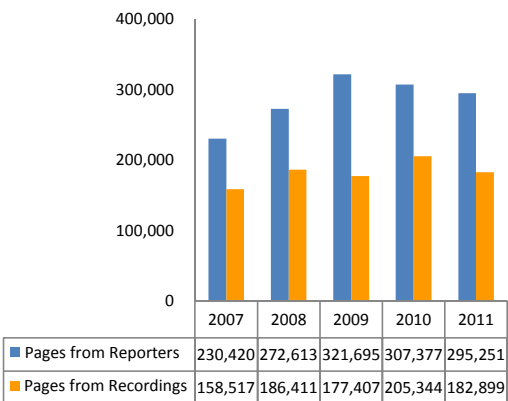
