- * Verdict split \$611,328.40 and \$11,251 between Plaintiffs. Greater award was settled for \$350,000 following post-trial mediation.
- ** Aggregate amount for all three plaintiffs.
- *** Jury found in favor of co-defendant WMATA.
- **** Pursuant to a pre-trial stipulation, the judgment was reduced to \$75,000 and plaintiff received \$25,000 prior to trial.
- ***** Post-verdict, the parties filed a praecipe noting that the case was settled and dismissed.
- ***** By previous agreement of the parties, the judgment amount would be \$7,500 if the jury found that the plaintiff was liable and \$25,000 if the defendant was found liable.
- ***** Reduced to \$75,000 by consent of the parties due to applicable coverage limits.
- ***** Defendant stipulated to liability.
