## CJA AND CCAN HOURLY RATES AND STATUTORY LIMITS FOR THE DISTRICT OF COLUMBIA COURT OF APPEALS

The following are the billing hourly rates and statutory case limits for counsel appointed by the **District of Columbia Court of Appeals**. The <u>notice of appeal</u> date and <u>case type</u> determines the hourly rate and the maximum amount to which an attorney is allowed to seek payment for. It should be noted that the statutory maximum is inclusive of travel time and itemized expenses.

- A voucher exceeding the case maximum may not be filed prior to the case having been: calendared, disposed of, or prior to an attorney withdrawing or having been removed from the case.
- The payment amount sought on a supplemental voucher(s) in addition to payment received on an interim voucher may not have a combined total that exceeds the case maximum. However, a supplemental voucher seeking payment for work related to the filing of a Petition for Writ of Certiorari is not added to any prior payments received and is subject to the maximum set for that case.
- If the total payment amount sought exceeds the case maximum, a Letter of Explanation, addressed to Chief Judge Washington must accompany the voucher.
