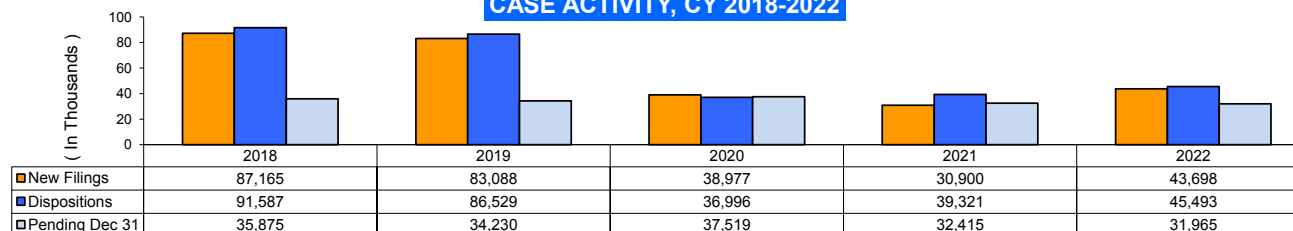

^eThe Extreme Risk Protection Order (EPO) is a new case type added to the Division's caseload under the Omnibus Emergency Amendment Act of 2018, can be filed by asking the court to remove firearms, ammunitions, certificates, licenses, and/or registrations from a person who poses a significant risk to themselves or others. In addition, the Anti Stalking Orders (ASO) Amendment Act of 2020 (Amendment Act), another new case type, is a court order in which a judge can require a person to follow certain requirements, including but not limited to, staying away from, not contacting, or committing any offense against the person requesting the ASO.

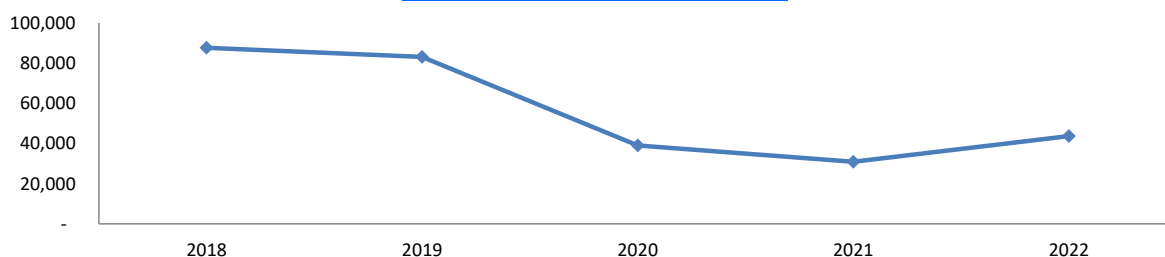
CASE ACTIVITY, CY 2018-2022

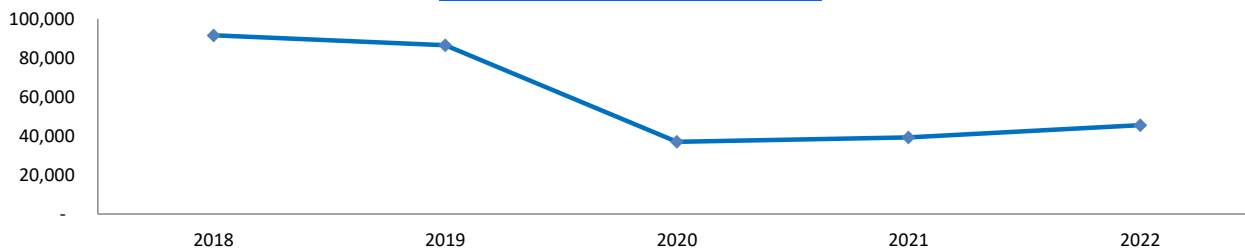
NEW CASE FILINGS TREND

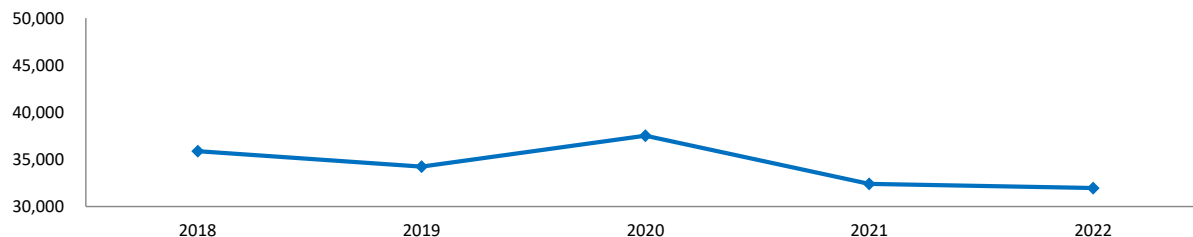

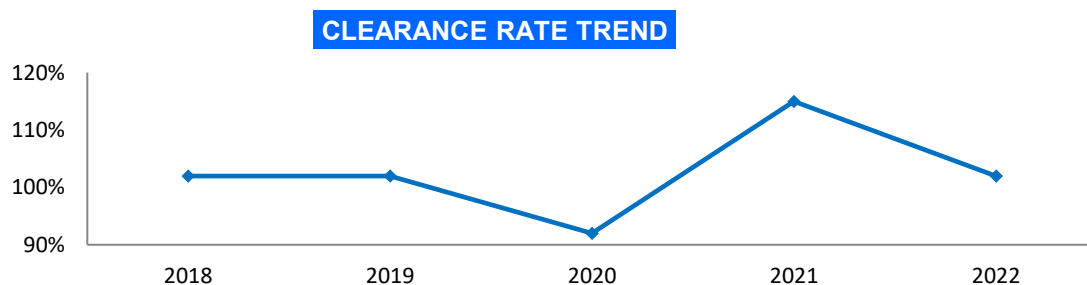

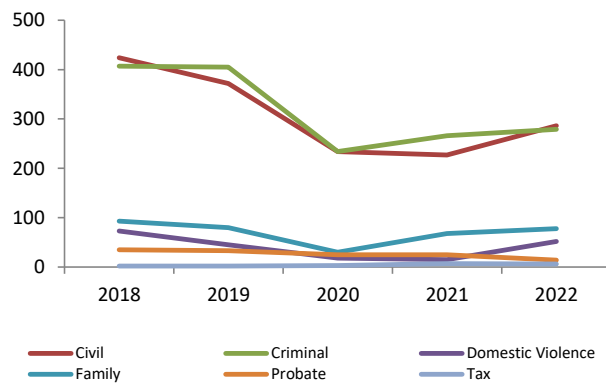

Trend in Appeals, CY2018-2022



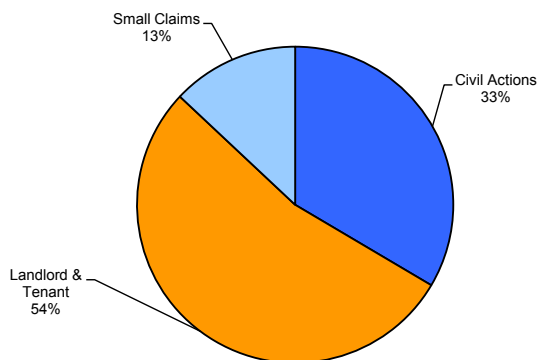

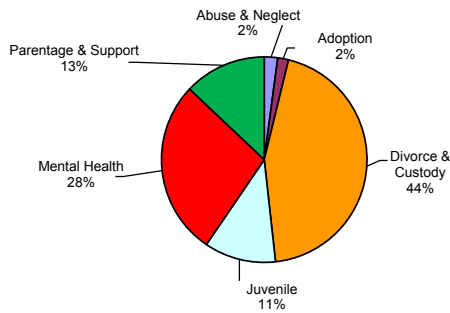

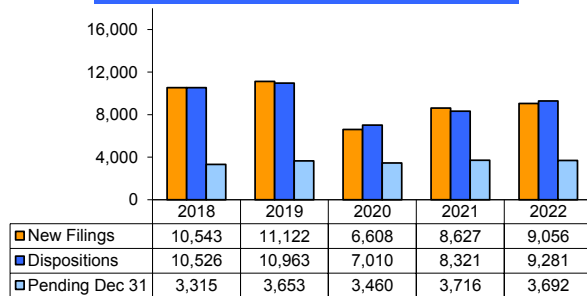

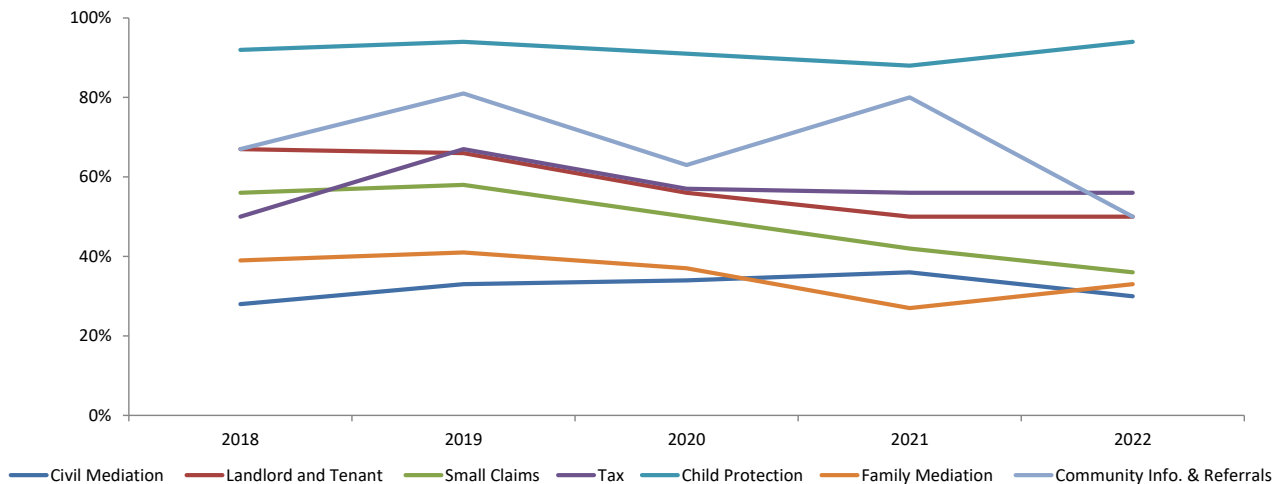

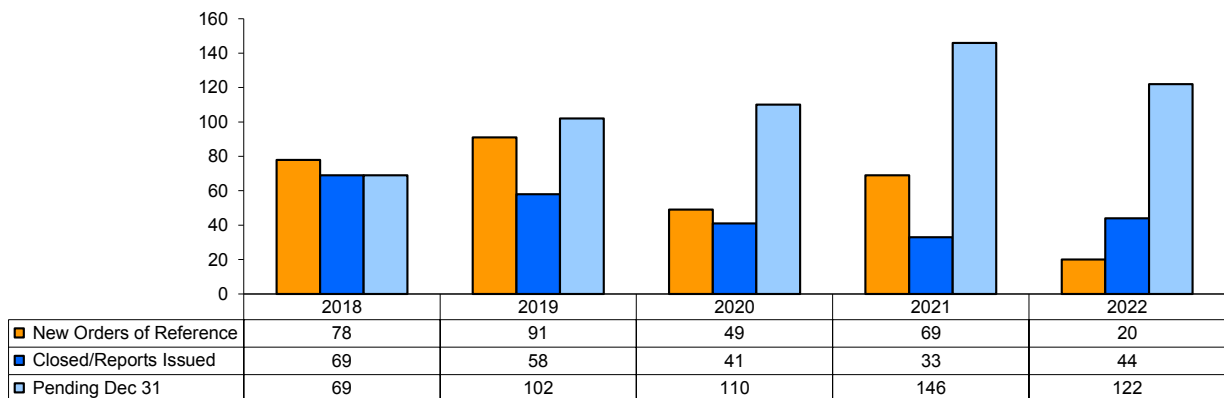

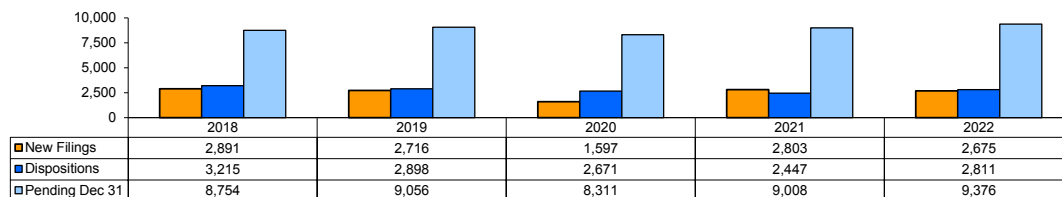

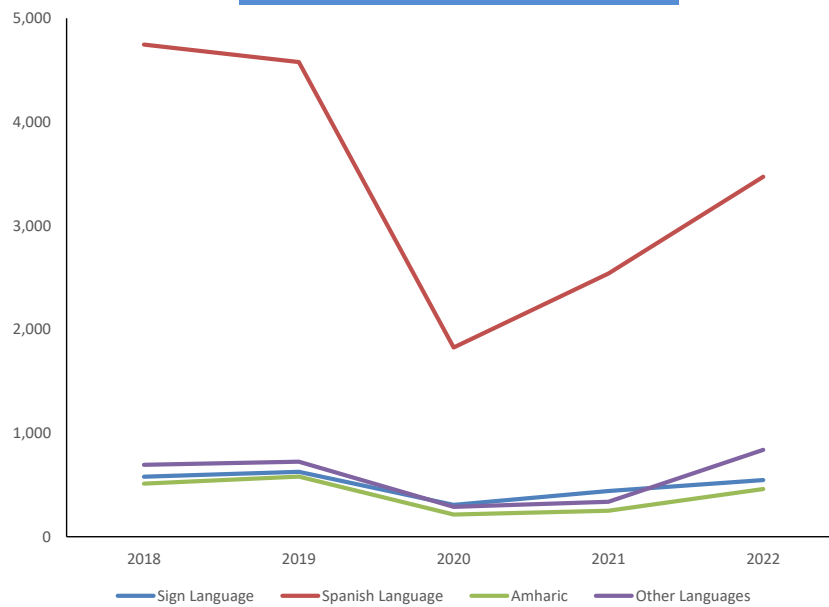

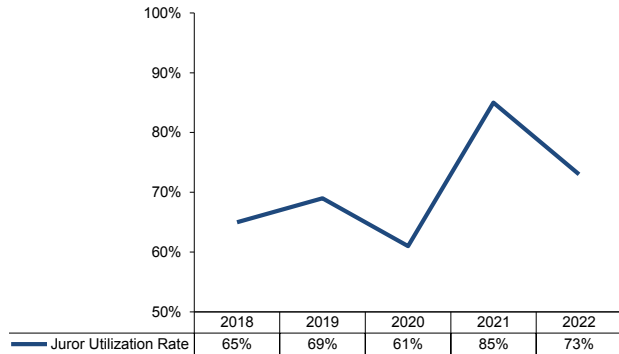
