SUPERIOR COURT OF THE DISTRICT OF COLUMBIA

DOMESTIC VIOLENCE DIVISION SCHEDULING ORDER

WHEREAS, in instances of emergency conditions, whether natural or otherwise, that significantly disrupt access to the operations of one or more courts or other judicial facilities of the District of Columbia or the ability of the Judiciary to operate effectively, the Joint Committee and the Chief Judges of the Court of Appeals and the Superior Court may be required to determine the extent to which court operations or judicial functions shall be modified and continue; and

WHEREAS, pursuant to D.C. Code § 11-947(c), the Chief Judge of the D.C. Superior Court has issued an emergency order dated March 18, 2020 suspending all statutory and rule based timelines and modifying the operations of the court;

IT IS HEREBY ORDERED that through May 15, 2020, criminal cases in the Domestic Violence Division of the District of Columbia Superior Court shall proceed in the manner and on the schedule set forth and attached hereto as Addendum A, which shall be incorporated by reference into this Domestic Violence Division Scheduling Order; and

IT IS FURTHER ORDERED that through May 15, 2020, civil cases in the Domestic Violence Division of the District of Columbia Superior Court shall proceed in the manner and on the schedule set forth and attached hereto as Addendum B, which shall be incorporated by reference into this Domestic Violence Division Scheduling Order; and

IT IS FURTHER ORDERED that individual judges need not issue orders in each of their cases to effectuate the schedule in Addendum A or Addendum B. If individual judges find it necessary to amend the schedule, it may be amended in any given case by individual order issued from the judge's chambers. Any individual chambers order shall supersede this Domestic Violence Division Scheduling Order.

ADDENDUM A

SCHEDULING OF DOMESTIC VIOLENCE MISDEMEANOR (DVM) AND CRIMINAL CONTEMPT (CCC) CASES THROUGH MAY 15th, 2020

Appearances: Counsel, Pretrial, and CSOSA may appear by telephone with the permission of the court for all hearings except for matters in C10.

DVD Clerk's Office: The clerk's office will be available remotely for inquiries.

DVM Arraignments will proceed as scheduled but will take place in Courtroom C10. CCC arraignments will be continued to a date after May 15th, 2020.

Non-Jury Trials for Non-Detained Defendants: All non-jury trials for non-detained defendants shall be converted to status hearings and continued to the date set forth in the schedule in Fig. 1: Continued Non-Detained DVM and CCC Schedule.

Matters Other than Trial for Non-Detained Defendants: All other previously scheduled matters for non-detained defendants, including but not limited to status hearings, diversion matters, mental observation hearings, and sentencings, shall be continued to the date set forth in the schedule in Fig. 1: Continued Non-Detained DVM and CCC Schedule.

Pretrial and Probation Show Cause Hearings may proceed when deemed necessary by the calendar judge and will be heard by the Criminal Division Emergency Judge in Courtroom 115 where appropriate. Non-emergency show cause hearings will be continued to the date set forth in the schedule in Fig.1: Continued Non-Detained DVM and CCC Schedule. New show cause hearings may be scheduled based on requests for expedited hearings. All requests for expedited pretrial and probation show cause hearings shall be filed in the Criminal AVR Inbox. AVRs or pretrial reports that do not contain an expedited hearing request will be addressed after the court returns to normal operations.

Emergency Motions, including emergency bond review motions, that require a hearing will be heard by the Criminal Division Emergency Judge in Courtroom 115.

Bench warrant returns in DVM and CCC cases will be heard by the Criminal Division Emergency Judge in Courtroom 115.

Notices and new orders will be issued and mailed to parties when practicable. Any new cases filed before May 15th will follow that same schedule.

Existing TPO and CPOs will remain in effect and will be extended through May 15th, 2020, or to the next assigned court date.

DVD Clerk's Office: The Clerk's Office will be available remotely by phone and email for inquiries. Phone lines will remain open during business hours 8:30am-5pm at (202) 879-0157 or by email at domesticviolencemanagement@dcsc.gov.

DV Intake Centers: The Domestic Violence Intake Centers will be closed, but you can be connected with resources through the DC SAFE Critical Response Team at (800) 407-5048 which is available 24/7. Additionally, a list of legal service providers can be found in the document titled Legal Assistance in Civil Domestic Violence Matters, which is available at https://www.dccourts.gov/coronavirus.

Emergency Requests: If you are in immediate danger, you should call 911. If you want to request a Temporary Protection Order (TPO), you can do so in two ways: You can contact the DC SAFE Critical Response Team (CRT) at (800) 407-5048, and they can assist you with obtaining a TPO. Or you may file a Petition for a Civil Protection Order and request a TPO through www.probono.net/dccourts. You can complete and submit the forms electronically through www.probono.net/dccourts. Once you complete and submit the form, please contact the Clerk's Office to proceed with the filing by phone at (202) 897-0157 or by email at domesticviolencemanagement@dcsc.gov.

If you have been served with a Temporary Protection Order or a Civil Protection Order and have a question about filing an emergency request, you can contact the Clerk's Office at (202) 879-0157.
