## ORDER ENTERING DEFAULT AND TEMPORARY CUSTODY ORDER

This matter came before the Court on November 13, 2023 for a status hearing on Plaintiff Estefany Y. Cortez Cruz' *Complaint for Custody*, filed June 9, 2023, concerning custody of minor child Lucy Alejandra Amaya Cortez (DOB: 9/27/2014). Plaintiff is the minor child's mother, and Defendant Alejandro Amaya is the minor child's father. Plaintiff was present *pro se*, and Defendant did not appear. A court-certified Spanish interpreter was also present.

On September 27, 2023, the Court granted Plaintiff's *Motion to Serve by Publication or Posting*. Subsequently, the Family Court Clerk's Office posted a copy of the Complaint and notice of the November 13, 2023 hearing at its office and on its website from September 28, 2023 to October 20, 2023.

Defendant Alejandro Cortez did not appear for the November 13, 2023 hearing, request a continuance of the hearing date, or otherwise file a responsive pleading. Pursuant to the Rules governing Domestic Relations Proceedings, Rule 55(a), "[w]hen a party against whom a judgment for affirmative relief is sought has failed to plead or otherwise defend, the clerk or court must enter

the party's default." Accordingly, the Court entered a default against Defendant for failing to appear and participate as required.<sup>1</sup>

At the hearing, the Court scheduled this matter for a default/*ex parte* proof hearing on **January 12, 2024 at 4:00 PM** in Courtroom 104. The hearing will be in person. At that time, the Court will hear evidence from Plaintiff on Plaintiff's request for a permanent custody order. If Plaintiff wishes, she may bring witnesses or exhibits that support her position as to what custody arrangement would be in the best interest of the minor child.

The Court stated that, before the Court may proceed to the entry of default judgment against a party who has not appeared in this action, Plaintiff was required to file a fully complete Affidavit in Support of Default in Compliance with the Servicemembers Civil Relief Act of 2003 ("SCRA Affidavit"). If Plaintiff has questions about how to make this request, she may contact the Family Court Self-Help Center located at Moultrie Courthouse, 500 Indiana Ave. NW, Room JM-570, Washington, D.C. 20001, telephone 202-879-0096.

During the hearing, Plaintiff testified that Defendant is not involved in the minor child's life and has never met the minor child since she was born, despite Plaintiff's belief that Defendant continues to reside in the Washington, D.C. area. Plaintiff requested an award of temporary sole legal and sole physical custody of the minor child, and the Court found that it was in the minor child's best interest to grant her request.

Wherefore, based upon the pleadings, sworn testimony, records in this case, and in consideration of the best interests of the minor children pursuant to D.C. Code §16-914 (a)(3)(A) through (Q) and § 16-4602.01, it is this **27th** day of **November 2023**, hereby

**ORDERED** that default is entered against Defendant Alejandro Amaya for failure to participate in this matter in violation of Rule 55(a); and it is further

**ORDERED** that, prior to the default/*ex parte* proof hearing on January 12, 2024, Plaintiff must file a fully complete Affidavit in Support of Default in Compliance with the Servicemembers Civil Relief Act of 2003 ("SCRA Affidavit"); and it is further

**ORDERED** that Plaintiff Estefany Y. Cortez Cruz is awarded **TEMPORARY SOLE LEGAL CUSTODY** of the minor child Lucy Alejandra Amaya Cortez (DOB: 9/27/2014); and it is further

**ORDERED** that consistent with the award herein of sole legal custody, Plaintiff has the authority to obtain medical services for the minor child, access documents necessary to address the minor child's needs, obtain a passport for the minor child, and receive any eligible government support or benefits for the minor child; and it is further

ORDERED that Plaintiff Estefany Y. Cortez Cruz is awarded TEMPORARY SOLE PHYSICAL CUSTODY of the minor child Lucy Alejandra Amaya Cortez (DOB: 9/27/2014); and it is further

**ORDERED** that the attached notice shall be posted in the Clerk's Office of the Family Court of the Superior Court of the District of Columbia and on the Superior Court's website for a period of twenty-one (21) calendar days in order to serve Defendant and notify him of the present action in which he is a party; and it is further

**ORDERED** that the parties shall appear for a default/*ex parte* proof hearing on

January 12, 2024 at 4:00 PM in Courtroom 104 of the Moultrie Courthouse, 500 Indiana Ave.

NW, Washington, DC 20001. **The hearing will be held in person**. Failure to appear may result in a default judgment, sanctions, or dismissal.
