SCHEDULING ORDER AND ORDER FOR SERVICE BY POSTING

This matter was scheduled to come before the Court on February 19, 2026, for a status hearing on the Plaintiff's Second Amended Complaint for Third Party Custody, filed on November 20, 2025. On January 20, 2026, the Court issued an *Order Continuing Hearing and Order for Service by Posting* (the "Order"), which continued a January 21, 2026 hearing, granted the Plaintiffs' *Motion for Alternative Service*, and ordered that an attached notice be posted in the Clerk's Office and on the Superior Court's website for a period of twenty-one (21) calendar days in order to serve Defendant Tillman and notify him of the present action in which he is a party. Due to technological issues with the court's filing system, as of the date of the February 19, 2026 status hearing, the Order has not been processed onto the docket, and as such, the notice that was attached to the Order has not been posted for the requisite twenty-one days. The Court will continue the February 19, 2026, hearing and order that the notice attached hereto be posted.

WHEREFORE, it is this February 19, 2026, hereby

ORDERED, that the attached notice shall be posted in the Clerk's Office of the Family Court of the Superior Court of the District of Columbia and on the Superior Court's website for a

period of twenty-one (21) calendar days in order to serve Defendant Tillman and notify him of the present action in which he is a party. It is further

ORDERED that the hearing on February 19, 2026 is **CONTINUED**. It is further

ORDERED, that the parties shall appear for a status hearing on **March 18, 2026, at 10:15 a.m. in Courtroom 104 of the Moultrie Courthouse, 500 Indiana Avenue, N.W., Washington, DC 20001**. Failure to appear at a hearing may result in the issuance of a default judgment, dismissal of the complaint, or sanctions.

IF YOU DO NOT WANT TO CHALLENGE THIS COMPLAINT, you may consent to the relief sought prior to the status hearing scheduled for March 18, 2026, at 10:15 a.m. in Courtroom 104.
