ORDER GRANTING MOTION

This matter comes before the Court on, *The District of Columbia's Third Motion to Extend the Service Deadline and to Allow Service by Alternative Methods* ("Motion"), filed by Plaintiff District of Columbia, through counsel, on October 2, 2025. The Plaintiff requests to serve the Defendant by alternative methods and for an extension of the service deadline to November 21, 2025, which is the date of the currently scheduled Remote Initial Scheduling Conference. *See generally* Mot.

Pursuant to Super. Ct. Civ. R. 4(e)(3)(A), "[i]f the court determines that, after diligent effort, a party has been unable to accomplish service by a method prescribed in Rule 4(c) or 4(e)(1)-(2), the court may permit an alternative method of service that the court determines is reasonably calculated to give actual notice of the action to the party to be served." When moving for alternative service methods under Super. Ct. Civ. R. 4(e)(3)(A), the movant must, "file a motion with an affidavit specifying the diligent efforts to serve by methods prescribed in Rule 4(c) or (e)(1)-(2)." Super. Ct. Civ. R. 4(e)(3)(C). Pursuant to Super. Ct. Civ. R. 9-I, an unsworn declaration is permitted to be substituted for an affidavit when there are no laws providing otherwise.

Pursuant to Super. Ct. Civ. R. 6(b)(1), "[w]hen an act may or must be done within a

specified time, the court may, for good cause, extend the time.” Pursuant to Super. Ct. Civ. R. 4(m)(2), “[p]rior to the expiration of any of the foregoing time periods, the plaintiff may make a motion to extend the time for service. The motion must set forth in detail the efforts that have been made, and will be made in the future, to obtain service.”

In the instant Motion, the Plaintiff requests to serve the Defendant by (1) posting the summons, complaint, and all other court orders on the door of the Defendant’s last known address at 11900 Crestwood Turn, Brandywine, Maryland 20613 (“the 11900 Crestwood address”) and (2) mail the summons, complaint, and all other court orders by first-class mail to the 11900 Crestwood Address. *See* Mot. 5. In support of their request for alternative service, the Plaintiff filed Declarations by two Investigators for the Office of the Attorney General for the District of Columbia pursuant to Super. Ct. Civ. R. 9-I. *See* Mot. Exs. 1-3.

The Court finds these Declarations satisfy Super. Ct. Civ. R. 9-I and Super Ct. Civ. Rs. 4(e)(3)(a) and 4(e)(3)(c) for alternative service by detailing the Plaintiff’s diligent efforts to serve the Defendant. After failing to serve the Defendant at two addresses, Investigator Anthony Rembert states he confirmed that the 11900 Crestwood address was the Defendant’s address through a criminal investigation. *See* Mot. Ex. 1 ¶ 5. That investigation also revealed the 11900 Crestwood address is associated with the Defendant’s Maryland criminal case in the Anne Arundel County District Court, D-07-CR-25-001205, and that Karen Johnson is the homeowner of the 11900 Crestwood address. *See id.* ¶¶ 4-6.

On June 5, 2025, Investigator Rembert states he visited the 11900 Crestwood address and received no answer. *See id.* ¶ 7. On that same day, Attorney Antoini Martin Jones, who represents Karen Johnson and has made a virtual appearance in the Maryland criminal case on behalf of the Defendant, contacted Investigator Rembert and stated that the Defendant’s whereabouts are

currently unknown and that he is “unwelcome” at the 11900 Crestwood address. *See id.* ¶ 8. However, on July 24, 2025, Investigator Tyrone Mabson states that the Defendant’s aunt advised him that the Defendant resides at the 11900 Crestwood address with his mother. *See Mot. Ex. 2* ¶ 4.

Additionally, Investigator Rembert states that he searched prison and jail databases, but found no record of incarceration for the Defendant and that the Anne Arundel County Sheriff has also been unable to locate the Defendant for service. *See Ex. 1* ¶¶ 10, 12. As of September 22, 2025, Investigator Rembert states he was informed by someone at the Anne Arundel County District Court that the Defendant’s Maryland criminal case did not have an assigned court date due to lack of service. *See Ex. 3* ¶ 5.

The Court not only finds that these Declarations demonstrate the Plaintiff’s diligent efforts to serve the Defendant, but also that the requested alternative service methods are reasonably calculated to give actual notice to the Defendant. While Investigator Rembert stated that Attorney Jones advised him that the Defendant is not “welcomed” at the 11900 Crestwood address and there is conflicting information as to whether the Defendant resides at that address, the 11900 Crestwood address is the only address currently associated with the Defendant. *See Mot. 2-3; Ex. 1* ¶ 5; *Ex. 2* ¶ 4. However, due to the Defendant’s unknown current whereabouts, the Court finds that alternative service by publication pursuant to Super. Ct. Civ. R. 4-I is also appropriate.

Additionally, the Court finds good cause to extend the service deadline pursuant to Super. Ct. Civ. Rs. 6(b)(1) and 4(m)(2). The Plaintiff filed the instant Motion prior to the current service deadline of October 3, 2025 and the Motion, the representations therein, and the supporting Declarations detail the efforts the Plaintiff has made to serve the Defendant. *See generally Mot.;* *Mot. Ex. 1-3.* The Plaintiff’s requests for alternative service also detail the efforts that will be made

to obtain service in the future. The Court will extend deadline to serve the Defendant to February 20, 2026 and the Remote Initial Scheduling Conference scheduled for November 21, 2025 will be rescheduled accordingly.

Upon finding good cause and Super. Ct. Civ. R 4 satisfied, the instant Motion is granted.

Wherefore, it is this 3rd day of November 2025 hereby:

ORDERED that The District of Columbia's Third Motion to Extend the Service Deadline and to Allow Service by Alternative Methods is **GRANTED**; and it is


ORDERED that the Plaintiff shall serve the Defendant by (1) posting a copy of the Summons, Complaint, Initial Order, and all Court Orders to the front door of 11900 Crestwood Turn, Brandywine, Maryland 20613 **and** (2) mailing a copy of the Summons, Complaint, Initial Order, and all Court Orders by first-class mail to 11900 Crestwood Turn, Brandywine, Maryland 20613; and it is

ORDERED that the Plaintiff shall also serve the Defendant by publishing the required documents and file an affidavit pursuant to Super. Ct. Civ. R. 4-I; and it is

ORDERED that the deadline for the Plaintiff to serve the Defendant with the required documents and file the appropriate filings with the Court is **EXTENDED** to February 20, 2026; and it is further

ORDERED that the Remote Initial Scheduling Conference scheduled for November 21, 2025 is **RESCHEDULED** to **February 20, 2026, at 9:30 a.m.** The parties may appear in person for the hearing in Courtroom 517 but may also attend the hearing remotely. **Parties appearing remotely must appear on video.** The instructions for participating remotely are appended to this Order.




Tips for Using DC Courts Remote Hearing Sites







Please note the following guidelines for appearing in the virtual courtroom:

- (1) When you enter the virtual courtroom (by dialing in on a phone, or signing in through the website or app), you should not attempt to speak because another hearing may be underway. You should be automatically muted by the courtroom clerk when you first arrive. If you are using the WebEx website or the app, you may check in with the courtroom clerk using the “chat” function. If you are on a telephone, you should wait for your case to be called.

- (2) At the check-in time (which is specified in the Order setting the hearing), the courtroom clerk will perform a roll call to determine which parties and counsel are present. The courtroom clerk will then call the matters that are ready.
- (3) If parties or counsel “arrive” in the virtual courtroom after roll call, they should not attempt to speak because another hearing may be underway. If they are using the WebEx website or the app, they may check in with the courtroom clerk using the “chat” function. If they are calling in by telephone, they should wait for their case to be called.

If a party or counsel intends to rely on exhibits or other documents during the hearing, the party or counsel shall e-mail the exhibits to the Court at judgemeekchambers@dcsc.gov, copying all sides, no later than 5:00 p.m. the three days before the hearing. The party or counsel must also file the exhibits on the docket using the Court’s case management system and provide a copy of the exhibit to any witness before the hearing. The exhibits must be separately labeled so that they can be easily identified by all parties and the Court during the remote hearing.




Tips for Using DC Courts Remote Hearing Sites

COMPLAINT

The District of Columbia (the District) brings this action against Defendant Charles V. Sanders Jr. under the Strengthening Traffic Enforcement, Education, and Responsibility Amendment Act of 2024, D.C. Code § 50-2201.04(g)(1) (STEER Act), and the Delinquent Debt Recovery Act, D.C. Code § 1-350.06(6), for 344 traffic citations—all but one for dangerous and unsafe driving offenses—totaling \$187,200 in unpaid fines, penalties, and fees owed to the District of Columbia. In support of its claims, the District states as follows:

INTRODUCTION

1. Defendant Charles V. Sanders Jr. is a clear threat to public safety. In just over two years, May 2020 through July 2022, Defendant Sanders and his associated vehicles amassed a staggering 344 citations for traffic infractions on his registered Maryland license plate and driver's license. Of those tickets, 339 were accrued over a period of a little more than a year—from March 2021 through July 2022. During that 499-day time period, Defendant Sanders accrued an astonishing average of almost *five tickets a week*.

2. All but one of Defendant Sanders's traffic citations are for unsafe driving. Further, all but 28 of Defendant Sanders's citations are for excessive speeding in the District. Defendant Sanders received a total of 316 traffic citations for speeding. Of those 316 traffic citations, 114 were issued for driving 11-15 miles per hour above the speed limit, 74 were issued for driving 16-20 miles per hour above the speed limit, and one was issued for driving at an unreasonable speed.

3. Additionally, and of deep concern, is that of the 316 speeding citations, 127 citations are for driving at speeds that would constitute reckless driving, or driving at least 20 miles per hour or more above the speed limit. D.C. Code § 50-2201.04(b)(1). Sixty-one of those 127 citations are for driving at speeds that would constitute aggravated reckless driving, or driving at least 30 miles per hour above the speed limit. D.C. Code § 50-2201.04(c)(1).

4. Rather than pay the almost two hundred thousand dollars in tickets he has amassed over the years, Defendant Sanders has blatantly acted as if there are no consequences for his lawlessness. As of the filing date, he owes the District \$187,200 in unpaid fines, penalties, and fees for his dangerous driving.

5. The District brings this action to hold Defendant Sanders accountable for accumulating an extraordinary number of traffic citations in a short period of time, collect the money he owes the District, and ensure that he stops endangering others and threatening public safety.

JURISDICTION

6. This Court has subject matter jurisdiction under D.C. Code § 11-921(a) and D.C. Code § 50-2201.04(g)(1)(A).

7. This Court has personal jurisdiction over Defendant Sanders under D.C. Code § 13-423(a)(3), because Defendant Sanders or an authorized driver was driving Defendant Sanders's vehicles in the District when the underlying traffic citations occurred, and under D.C. Code § 50-2201.04(g)(1)(A).

PARTIES

8. Plaintiff the District of Columbia, a municipal corporation empowered to sue and be sued, is the local government for the territory constituting the permanent seat of the government of the United States. The District is represented by and through its chief legal officer, the Attorney General for the District of Columbia. The Attorney General conducts the District's legal business and is responsible for upholding the public interest. D.C. Code § 1-301.81(a)(1).

9. Defendant Charles V. Sanders Jr. resides at 11900 Crestwood Turn, Brandywine, MD 20613.

10. Defendant Sanders is the sole registered owner of a vehicle associated with one Maryland license plate on which he owes debt.

11. Defendant Sanders holds a Maryland driver's license.

12. Defendant Sanders received numerous traffic citations in the District on his Maryland license plate and Maryland driver's license that have accumulated fines, penalties, and fees due to nonpayment.

THE DEPARTMENT OF MOTOR VEHICLES AND THE CENTRAL COLLECTION UNIT'S TRAFFIC INFRACTION DEBT COLLECTION PROCESS

13. The District of Columbia's Department of Motor Vehicles (DMV) manages the process for collecting traffic fines and adjudicating traffic violations. D.C. Code § 50-904(1)(A).

14. The District issues a Notice of Infraction for violations of traffic laws and regulations. D.C. Code § 50-2303.03. A Notice of Infraction may be issued by either a law enforcement officer or an automated traffic system.¹ 18 DCMR § 3003.1; D.C. Code § 50-2209.01(a).

15. The owner of a vehicle issued a Notice of Infraction is liable for payment of the fine assessed for the infraction. D.C. Code § 50-2209.02.

16. An individual who receives a Notice of Infraction may answer it by: (1) paying the fine; (2) admitting with an explanation; or (3) denying the infraction. D.C. Code §§ 50-2302.05(a), 2303.05(a)(1).

17. A civil fine for a traffic infraction varies based on the established amount for the offense. D.C. Code § 50-2301.05(a)(1); *see e.g.*, 18 DCMR §§ 2600, 2601. A penalty equal to the civil fine is imposed on an individual who fails to answer a Notice of Infraction within 30 calendar days of the notice issuance date. D.C. Code §§ 50-2302.05(d), 2303.05(d)(1).

18. If an individual fails to answer a Notice of Infraction within 60 calendar days, the traffic infraction will be deemed admitted and all fines and penalties will be assessed. D.C. Code §§ 50-2302.05(e), 2303.05(d)(2).

19. An individual may apply to vacate an admission within 60 calendar days of the deemed admission date by providing a defense to the traffic violation and reasons for the delay in answering to the traffic violation.² D.C. Code §§ 50-2302.05(i), 2303.05(f).

¹ An automated traffic system is “equipment that takes a film or digital camera-based photograph which is linked with a violation detection system that synchronizes the taking of a photograph with the occurrence of a traffic infraction.” D.C. Code §§ 50-2209.01(a), 2303.02a(a).

² For a traffic violation detected by an automated traffic enforcement device, an individual may apply to vacate a deemed admission within one year of the date of admission by providing a

20. After 120 days from the notice issuance, the DMV may refer debt arising from unpaid traffic infractions to the Office of the Chief Financial Officer (OCFO) Central Collection Unit (CCU) for collection. D.C. Code § 1-350.02(a). Included in the DMV's referrals are both tickets that were not adjudicated and tickets that were adjudicated but where liability was found.

21. CCU is a component of the OCFO. CCU was established under the Delinquent Debt Recovery Act. D.C. Code § 1-350.01(1). It is responsible for collecting delinquent debt owed to the District.³ D.C. Code § 1-350.02(a).

22. CCU imposes a 20 percent collection fee to delinquent debt owed from an unpaid traffic ticket. *Central Collection Unit Fee*, District of Columbia OCFO, https://cfo.dc.gov/sites/default/files/dc/sites/ocfo/publication/attachments/CCU%20Fee_Assignment.pdf, (last visited Feb. 10, 2025).

23. The DMV and CCU use an electronic Ticketing Information Management System (eTIMS) to facilitate referrals. This system stores all traffic tickets issued by, among other agencies, the District of Columbia Department of Public Works (DPW), the District of Columbia Department of Transportation (DDOT), and the Metropolitan Police Department (MPD). Tickets stored in eTIMS include, but are not limited to, moving violations ticketed by an officer, violations captured by an automated traffic enforcement device, and parking violations.

24. ETIMS is equipped to retrieve information from various electronic systems within the District, Maryland, and Virginia, which includes the names and addresses of registered license plate owners.

³ Delinquent Debt is any financial obligation owed to the District by an individual that remains unpaid more than 90 days after it due. D.C. Code § 1-350.01.

25. ETIMS consolidates all traffic infractions under the associated driver's license number and license plate. For each driver's license and license plate, eTIMS captures the: (1) ticket number; (2) status of the ticket; (3) violation date and time; (4) violation code and description; (5) make of the vehicle; (6) location of the violation and disposition of the ticket; (7) fine amount; (8) penalty; and (9) total amount due.

26. CCU contracts with Harris & Harris, Ltd. (Harris & Harris), a third-party collection agency, to collect delinquent debt owed to the District. Harris & Harris communicates with debtors in the form of letters and phone calls to collect delinquent debt. Harris & Harris uses an electronic database that captures every attempt made to collect debt and every communication sent to and received from a debtor. The system also captures the total debt in collections that includes all fines, penalties and fees.

DEFENDANT SANDERS'S OUTSTANDING TRAFFIC CITATIONS

27. CCU conducted an eTIMS search of Defendant Sanders's traffic citations associated with his driver's license number and license plate number registered in his name.

28. Defendant Sanders holds a Maryland driver's license **MDS536115843886**.

29. The District issued the following traffic tickets to Defendant Sanders under driver's license number **MDS536115843886**⁴:

30. DMV records reflect that Defendant Sanders has five delinquent traffic tickets issued to his driver's license, totaling \$600.

31. DMV records reflect that four traffic citations were issued for dangerous and unsafe driving. Of those tickets, two were issued for running a red light, one was issued for speeding, and one was issued for operating a vehicle that was in an unsafe condition.

32. Defendant Sanders failed to answer and thus was deemed liable for all fines, penalties, and fees for these traffic infractions.

33. As of the filing date, Defendant Sanders owes the District \$600 for the traffic citations issued under driver's license number **MDS536115843886**.

34. Defendant Sanders is the sole registered owner of one Maryland license plate on which he owes delinquent debt, license plate **MD9EM3868**.

35. This license plate is associated with a 2005 Toyota LE Camry with vehicle identification number (VIN) 4T1BE30KX56532865.

36. The District issued the following traffic citations to Defendant Sanders under license plate **MD9EM3868**:

37. In a short period of just over a year, Defendant Sanders accumulated an extraordinary amount of traffic citations on this license plate. In 2021 alone, Defendant Sanders amassed 200 traffic citations. One hundred seventy-eight were for excessive speeding. Similarly, in just six and a half months in 2022, Defendant Sanders amassed 140 traffic citations. One hundred thirty-seven citations were for excessive speeding.

38. DMV records currently reflect that Defendant Sanders has 339 delinquent traffic citations issued to this license plate, totaling \$186,600.

39. DMV records reflect that all 339 delinquent traffic citations on this license plate were issued for dangerous driving. Three hundred and fifteen of the 339 tickets on this license plate were issued for speeding. Of the 315 citations for speeding, 114 were issued for driving 11-15 miles per hour above the speed limit, and 74 were issued for driving 16-20 miles per hour above the speed limit.

40. One hundred and twenty-seven citations constitute reckless driving, or driving 20 miles per hour or more above the speed limit. D.C. Code § 50-2201.04(b)(1). Sixty-one of the 127 reckless driving citations constitute aggravated reckless driving, or driving 30 miles per hour or more above the speed limit. D.C. Code § 50-2201.04(c)(1).

41. Additionally, of the 339 traffic citations, nine were issued for running red lights; nine were issued for running stop signs; and six were issued for failing to come to a complete stop before turning right at a red light.

42. Defendant Sanders failed to answer and thus was deemed liable for all fines, penalties, and fees for these traffic infractions.

43. As of the filing date, Defendant Sanders owes the District \$186,600 for traffic citations issued under Maryland license plate **MD9EM3868**.

44. In total, Defendant Sanders has 344 delinquent traffic citations and owes the District \$187,200 in outstanding debt for failure to answer the associated fines, penalties, and fees associated with his Maryland driver's license and registered Maryland license plate.

45. The DMV contacted Defendant Sanders by mail, notifying him of each traffic infraction, the associated penalties, and the associated period to resolve each infraction. Overall, the DMV allotted Defendant 120 days from the date of each Notice of Infraction to contest or resolve any associated fines and penalties.

46. Due to Defendant Sanders's failure to resolve the traffic infractions with the DMV, the DMV referred Defendant's unpaid fines and penalties to CCU.

47. CCU, through Harris & Harris, attempted to collect the underlying delinquent debt on multiple occasions by telephone and postal mail but was unsuccessful.

48. On March 17, 2025, CCU sent Defendant Sanders a final demand letter notifying him of the unpaid delinquent debt and providing information on how to resolve it. Defendant Sanders failed to resolve the delinquent debt with CCU.

49. Thereafter, CCU referred this matter to the Office of the Attorney General for the District of Columbia to initiate a civil action to collect the debt.

COUNT I
VIOLATION OF THE STRENGTHENING TRAFFIC
ENFORCEMENT, EDUCATION, AND RESPONSIBILITY AMENDMENT ACT
D.C. CODE § 50-2201.04

50. The District incorporates by reference all allegations stated as previously set forth in paragraphs 1-49.

51. The District may bring a civil suit against any driver, or any motor vehicle alleged to have been driving at a rate of speed over a designated speed limit. D.C. Code § 50-2201.04(g)(1).

52. The owner of a registered vehicle is liable for payment of any fine and penalties associated with a traffic infraction. D.C. Code § 50-2209.02(a); *see also* D.C. Code § 50-2302.05(e) (“If a person fails to answer the notice within 60 calendar days after the date the notice was issued, . . . the commission of the infraction shall be deemed admitted and all points, penalties, and fines shall be assessed.”)

53. Defendant Sanders holds Maryland driver’s license **MDS536115843886**.

54. The District issued one speeding ticket to Defendant Sanders under Maryland driver’s license number **MDS536115843886**.

55. Defendant Sanders failed to answer and thus was deemed liable for the fine, penalty, and fee associated with this speeding infraction.

56. As of the filing date, Defendant Sanders owes the District \$180 for one speeding ticket out of the total \$600 delinquent debt under Maryland driver’s license number **MDS536115843886**.

57. At all relevant times, Defendant Sanders was the registered owner of Maryland license plate **MD9EM3868**.

58. The District issued citations for 315 speeding infractions to Defendant Sanders under Maryland license plate number **MD9EM3868**.

59. Defendant Sanders failed to answer and thus was deemed liable for all fines, penalties, and fees for these speeding infractions.

60. As of the filing date, Defendant Sanders owes the District \$179,760 for 315 delinquent speeding infractions out of the total \$186,000 delinquent debt under license plate number **MD9EM3868**.

61. In total, Defendant Sanders owes the District \$179,940 in outstanding delinquent debt for failure to answer or otherwise pay the associated fines, penalties, and fees associated with 316 delinquent speeding citations.

COUNT II
DEFENDANT'S DELINQUENT DEBT UNDER
THE DELINQUENT DEBT RECOVERY ACT
D.C. CODE § 1-350.06

62. The District incorporates by reference all allegations previously set forth in paragraphs 1-61.

63. CCU, in its discretion, may refer delinquent debt owed to the District to the Office of the Attorney General for civil enforcement. D.C. Code § 1-350.06(6).

64. CCU has referred to the Office of the Attorney General Defendant Sanders's delinquent debt arising from his nonpayment of 344 delinquent traffic citations.

65. As of the filing date, Defendant Sanders owes the District \$600 for all traffic citations issued under his Maryland driver's license number **MDS536115843886**.

66. As of the filing date, Defendant Sanders owes the District \$186,600 for traffic citations issued under Maryland license plate **MD9EM3868**.

67. As Defendant Sanders failed to answer the traffic citations associated with his driver's license number and registered license plate with the DMV noted above, Defendant Sanders owes the assessed fines, penalties, and fees to the District. The District now seeks \$187,200 from Defendant Sanders for all delinquent debt owed to the District arising from Defendant's outstanding traffic citations set forth in this Complaint.

PRAYER FOR RELIEF

Wherefore, the District respectfully requests that the Court enter judgment in its favor and against Defendant as follows:

- (1) Award the District \$187,200 for Defendant Sanders's unpaid fines, penalties and fees;
and
- (2) Award reasonable attorney's fees; and
- (3) Award the District such further and additional relief as the Court may deem just and proper.





How do I take part in a remote hearing?

The Court will give you step-by-step instructions on how to take part in the remote hearing.

Is there anything that I should do before the day of the hearing?

- Let the court know immediately if you cannot join a hearing because you do not have a phone or computer.

Tips for the Hearing



- Join the hearing a few minutes early!
- Charge your computer or phone and make sure you have enough minutes to join the call. Find a private and quiet space. If possible, be alone in a room during the hearing. Try to limit distractions as much as possible. If others are in the room with you, ask if they can be quiet during the hearing.
- Mute your microphone when you are not talking. Mute all sounds on your phone or computer.
- Say your name before you speak so the record is clear. Be prepared to identify your role in the hearing (e.g., observer, plaintiff, defendant, witness, etc.). 
- Speak slowly and clearly so everyone hears what you are saying.
- Pause before speaking in case there is a lag. Use a headset or headphones if you can. This will free up your hands and sound better.
- Try not to talk over anyone else. Only one person can speak at a time. If you talk while someone else is talking, the judge will not be able to hear you.
- Have all your documents for the hearing in front of you. Have a pen and paper to take notes.
- If you are not ready for your hearing or want to speak with an attorney, you can ask the judge to postpone your hearing for another date.
- If your sound or video freezes during the hearing, use the chat feature or call the Clerk's Office to let them know that you are having technical issues.

- Download the court's hearing software, WebEx, in advance and do a test run! The Court will provide you with a WebEx link in advance of the hearing.
- Set up the camera at eye level. If you are using your phone, prop it up so you can look at it without holding it.
- Look at the camera when you speak and avoid moving around on the video.
- Wear what you would normally wear to court.
- Sit in a well-lit room with no bright lights behind you.
- If possible, find a blank wall to sit in front of. Remember the judge will be able to see everything on your screen, so pick a location that is not distracting.
