# ORDER GRANTING PLAINTIFF'S MOTION FOR ALTERNATIVE SERVICE BY POSTING

This matter is before the Court upon consideration of Plaintiff Santos Candida Alfaro De Villanueva ("Plaintiff") Motion for Alternative Service by Posting on Defendant Mayara Analy Alfaro Carillo ("Defendant") and Nicolas Amilcar Pleitez Asencio ("Defendant") filed on 09/22/2025, and Supplemental Affidavit filed on 06/26/2025. The instant case involves a Complaint for Custody for one Minor Child. Plaintiff has filed a motion providing the details of his diligent search for Defendant, whose whereabouts are unknown. The Court will not repeat those details herein. The Court is satisfied that Plaintiff has made a diligent investigation of Defendant's whereabouts for purposes of ordinary service of process. The search was not successful. Furthermore, Plaintiff has given an adequate explanation of why his should be allowed to serve Defendant through posting in the Clerk's office or on the Court's

website at <a href="https://dccourts.gov/services/serve-notice">https://dccourts.gov/services/serve-notice</a> rather than by publication in a newspaper. The reason is economic.

**ORDERED** that Plaintiff's Motion for Alterative Service by Posting is hereby **GRANTED**; and it is

**FURTHER ORDERED** that Plaintiff may serve Nicolas Amilcar Pleitez Asencio the father of the Minor Child, A.A. and Mayara Analy Alfaro Carillo, the mother of the Minor Child, A.A. (DOB: 09/26/2011) by posting on the Superior Court for the District of Columbia's website for a period of twenty-one (21) calendar days and in the Domestic Relations Clerk's Office, starting with the date of this order; and it is

FURTHER ORDERED that if Defendant Mayara Analy Alfaro Carillo and Nicolas Amilcar Pleitez Asencio do not file a responsive pleading within twenty-one (21) days after service pursuant to the Rules Governing Domestic Relations Proceedings, Rule 12(a), Plaintiff may file a motion for default and the Court may enter default by order and may convert the next hearing into a default/ex parte hearing to take testimony from Plaintiff and file a final judgment without Defendant Mayara Analy Alfaro Carillo and Nicolas Amilcar Pleitez Asencio's participation, and it is

**FURTHER ORDERED**, that if Plaintiff is seeking a default judgment, prior to the next scheduling hearing, Plaintiff shall file an Affidavit in Compliance with the Servicemembers Civil Relief Act; and it is

**FURTHER ORDERED**, that a hearing on Plaintiff's Complaint for Custody and Motion for Special Immigrant Juvenile Status is scheduled for **December 12, 2025 at 3:00 p.m.** before Magistrate Judge Melanie A. Acuña remotely on WebEx JM-16. Instructions on how to appear remotely are attached to this order.
