THE MOTHER**



IF YOU WANT TO CHALLENGE THIS MOTION, you must file a written objection with the Court within fourteen (14) days, and appear for the hearing scheduled for November 29, 2023, at 3:00 p.m. on Webex 99, that will be held remotely due to the coronavirus pandemic. Instructions to appear remotely are stated below and can be obtained in writing by contacting the chambers of Judge Breslow at **MagistrateJudgeBreslowChambers@dcsc.gov** in advance of the hearing.

If you do not file a written objection within fourteen (14) days or appear at the hearing, default may be entered against you, the hearing may be converted to a default/ex parte proof hearing and judgment may be entered without further proceedings. Your objection should be emailed to **FamilyCourtCIC@dcsc.gov**, and directed to the Family Court, Superior Court of the District of Columbia, 500 Indiana Avenue NW, Washington, D.C. 20001.
