The respondent, Bernal Metivier-Betermi, is a thirteen-year-old male child, born on April 11, 2008. Prior to petitioning this case, the respondent resided with his mother, Johanna Metivier-Betermi, and three siblings, Joshua Medina (DOB: 8/15/2015), Maybelline Herrara (DOB: 10/25/2011), and Sky Medina Metivier (DOB: 7/27/2018), in the District of Columbia. Ms. Metivier-Betermi identified the respondent's father as Mr. Bernardo Desmay. He

resides in the Dominican Republic and is not involved. The District does not have a copy of the respondent's birth certificate and has not obtained a document that adjudicates paternity. Paternity therefore remains unverified.

The family has extensive history with the Child and Family Services Agency ("CFSA"), beginning in 2010, for allegations of substance use, inadequate supervision, and exposure to domestic violence. In 2019, Ms. Metivier-Betermi came to CFSA's attention when Mr. Oliver Medina-Salazar, the father of Joshua and Sky, passed away from an overdose in the presence of the children. Reportedly, Ms. Metivier-Betermi was using drugs with Mr. Medina-Salazar at the time of his overdose and afterwards was hospitalized overnight for suicidal ideations. CFSA substantiated Ms. Metivier-Betermi for neglect-substance use by a caregiver. As a result, an in-home case was opened and remained open at the time of the removal.

The in-home social worker, Mr. Alexander Goodwill, has noticed a deterioration of Ms. Metivier-Betermi over the last six months. In spring 2021, La Clinica del Pueblo, a substance abuse treatment program, discharged Ms. Metivier-Betermi for non-compliance. La Clinica del Pueblo strongly recommended that Ms. Metivier-Betermi enter an inpatient program to address her chronic alcoholism and cocaine addiction. At first, Ms. Metivier-Betermi recognized that she needed that level of intervention, but then decided against going into inpatient treatment, using the pretext of having no one to care for her children while she was away. Instead, Ms. Metivier-Betermi connected with Volunteers of America, an outpatient treatment program, for substance abuse and mental health services. Despite, being connected to this core service agency, concerns around Ms. Metivier-Betermi's substance use and mental health remain.

Most recently, the family came to CFSA's attention on November 30, 2021, when a mandated reporter called the hotline to report that Joshua disclosed that Ms. Metivier-Betermi burned his right hand on the stove, because he took a KitKat. Joshua missed the entire week of school last week and did not go to school on Monday, November 29, 2021, because his hand hurt so bad that he was unable to sleep. Joshua also reported that he was hungry and has not been eating. The reporter observed scabs and open skin on Joshua's right hand. The reporter started that it appeared as though Joshua's hand was burned on one side and then flipped over and burned on the other. The inner parts of Joshua's index finger and thumb were also burned. Joshua told the reporter that his current level of pain was a "10".

CFSA assigned investigating social worker, Jasmine Hockaday, to investigate the allegations in the report. On November 30, 2021, Ms. Hockaday met with Ms. Metivier-Betermi. Ms. Metivier-Betermi appeared to be under the influence because she was observed fidgeting and laughing at inappropriate times. Ms. Metivier-Betermi reported that she keeps chocolates in the refrigerator for her "witch doctor". She stated she disciplined Joshua for eating all the chocolates. Ms. Metivier-Betermi also expressed that she does not want Joshua to be a thief and she told him that if he is a thief then the police (whom she referred to as "dogs"), will come and kill him. Ms. Metivier-Betermi stated that she wanted to "teach Joshua a lesson" about not stealing and so she grabbed his hand and placed it into hot water on the stove. She stated that she later put "cream" on the burn and expressed that she did not feel the burn was serious enough to require medical attention.

Ms. Metivier-Betermi reported that her other children do not give her any trouble, but Joshua has "issues", and a history of stealing and saying he wants to kill himself and others. She stated that she used to discipline Joshua by making him take cold showers, but she no longer uses this method, because someone told her to stop. Ms. Metivier-Betermi reported that she now disciplines Joshua by making him sit on his knees for six minutes.

Ms. Metivier-Betermi disclosed that she is diagnosed with depression and takes mirtazapine to treat it. She also disclosed that she has a history of using alcohol and cocaine. She reported that she is enrolled in a substance abuse program, Volunteers of America, and has been sober for two weeks. Ms. Metivier-Betermi only admitted to a diagnosis of depression, but upon information and belief, she has also been diagnosed with adjustment disorder and acute stress disorder. Upon information and belief, she has a history of three suicide attempts. Upon information and belief, Ms. Metivier-Betermi is prescribed sertraline and trazadone, but she is not medication complaint.

On November 30, 2021, Ms. Hockaday, met with Child and Adolescent Protection Center doctor, Dr. Adrienne Artis, who conducted the comprehensive examination of Joshua. Dr. Artis reported that Joshua disclosed that he got in trouble with Ms. Metivier-Betermi for eating too much candy and she grabbed his hand and placed it on the stove. Dr. Artis was unable to confirm whether the burn was intentional or unintentional, however, she stated that Joshua was very adamant and clear Ms. Metivier-Betermi burned his hand intentionally. Dr. Artis also reported that Joshua would need to be seen at the Children's National Hospital Burn Center on December 1, 2021, to have the burn further assessed. She expressed concern that the burn was near a nerve and if it was not treated properly, Joshua might have long term issues with his hand. Dr. Artis and Ms. Hockaday observed an old mark on Joshua's head. Joshua was unable to say how he obtained the mark. Additionally, Dr. Artis reported that Joshua needed to be seen by a dentist, because he had significant tooth decay.

On November 30, 2021, Ms. Hockaday assessed and observed Joshua. He reported that he got in trouble for eating a lot of candy and Ms. Metivier-Betermi grabbed his hand and placed it on the hot stove. He described the stove as "black and white, has four black circles, and fire comes from it." Joshua also disclosed that Ms. Metivier-Betermi tried to place his other hand on the stove, but could not do so, because he ran and hid under his brother's bed. Joshua stated that he began to cry, and Ms. Metivier-Betermi eventually put a bandage on his injury.

On the same day, Ms. Hockaday assessed and observed Maybelline at her school. Maybelline presented as very nervous. She gave various accounts of what happened to Joshua. Maybelline reported that she did not know how Joshua obtained his burn, but thought that he accidently burned himself when he was reaching for something on the stove. She denied witnessing Joshua getting burned and stated she was in her room. Maybelline first stated that Ms. Metivier-Betermi was inside her bedroom sleeping, but later said that Ms. Metivier-Betermi was inside her bedroom watching TV. Maybelline reported that she left her room and observed Joshua on the floor crying. She told Ms. Metivier-Betermi and Ms. Metivier-Betermi then bandaged Joshua's hand. Ms. Hockaday observed no visible injuries on Maybelline.

Ms. Hockaday then assessed and observed Bernall at his home. Bernall presented as slightly withdrawn and emotional. He was observed to be crying. When Ms. Hockaday asked him about what happened to Joshua, he stated, "she did it." He continued to report that he witnessed Ms. Metivier-Betermi grab Joshua's hand and place it in a pot of hot water. He expressed that the incident happened recently, and he believed it occurred after Thanksgiving, but he was unable to provide more details. Ms. Hockaday observed no visible injuries on Bernall.

Ms. Hockaday then assessed and observed Sky. Sky was unable to be interviewed due to her age and stage of development. Ms. Hockaday observed no visible injuries on Sky.

Ms. Metivier-Betermi was arrested and charged with second degree cruelty to children under case number 2021 CF1 006827. Upon information and belief, a stay away order has been issued and Ms. Metivier-Betermi is ordered to stay away from all of her children.

The District submits that the above allegations are unrelated to the financial means of the parents.

The child comes within the jurisdiction of the Court under D.C. Code 16-2301(9)(A)(ii), (iii), and (v).

WHEREFORE, your petitioner prays the Court hear the matter here set forth and determine whether the child should be dealt under the applicable sections of the District of Columbia Code, as amended by PUBLIC LAW 91-358, July 29, 1970; and that the Division enter such judgment and order as it finds will best serve the child's welfare and the best interests of the public.

MEMORANDUM OF POINTS AND AUTHORITIES IN SUPPORT OF THE DISTRICT OF COLUMBIA'S MOTION FOR AN ORDER AUTHORIZING CONSTRUCTIVE SERVICE BY POSTING

CFSA removed Bernal Metivier Betermi from the care of his mother in December 2021. In December 2021, the District petitioned this case, alleging that the respondent is a neglected child under D.C. Code § 16-2301(9)(A)(ii), (iii), and (v). The Court held an initial hearing on December 3, 2021 and placed the respondent in shelter care. The neglect trial is scheduled on March 10, 2022, at 1:00 p.m. and March 11, 2022, at 11:00 a.m.

The mother named Bernardo Desmay as the father of the respondent. CFSA was not provided with a date of birth or phone number. CFSA located a potential last known address for Mr. Desmay, but no one answered the door at that location. CFSA was then informed that Mr. Desmay lives in the Dominican Republic, but no additional information was given. Based on the limited information provided, Mr. Desmay was unable to be located. See December 29, 2021, Affidavit of Efforts (attached).

In a neglect proceeding, the District is required to serve the child's parent with a summons and copy of the petition prior to the fact-finding hearing. D.C. Code § 16-2306(a); Super. Ct. Neg. R. 11(a). When the District is unable to effect personal or substitute service, the Court may authorize constructive service by other means the Court "deems appropriate." Super. Ct. Neg. R. 11(g)(3). The District cannot effect personal or substitute service on Bernardo Desmay because his current dwelling

or residence is unknown to the District, and he cannot be located, despite diligent efforts. Service by posting is therefore warranted. *In re E.S.N.*, 446 A.2d 16 (D.C. 1982) (finding that constructive service by posting was appropriate where diligent efforts to locate the father were unsuccessful).

Accordingly, the District requests that this Court order constructive service on Bernardo Desmay by posting notice on the Superior Court for the District of Columbia's website for two weeks.
