ORDER GRANTING PLAINTIFF'S MOTION FOR ALTERNATIVE SERVICE BY POSTING ON THE UNKNOWN FATHER

This matter is before the Court upon consideration of Plaintiff Liliana Carolina Torres Sanchez ("Plaintiff") Motion for Alternative Service on Defendant Unknown Father ("Defendant Unknown Father") filed on March 18, 2024. The instant case involves a Complaint for Custody for one Minor Child. Plaintiff has filed a motion providing the details of her diligent search for Defendant Unknown Father, whose identity is unknown. The court will not repeat those details herein. The Court is satisfied that Plaintiff has made a diligent investigation of Defendant Unknown Father identity and whereabouts for purposes of ordinary service of process. The search was not successful. Furthermore, Plaintiff has given an adequate explanation of why she should be allowed to serve Defendant Unknown Father posting in the Clerk's office or on the Court's website at <u>https://dccourts.gov/services/serve-</u> notice rather than by publication in a newspaper. The reason is economic.

ORDERED that Plaintiff's Motion for Alternative Service on Unknown Father filed on March 18, 2024, is hereby **GRANTED**; and it is **FURTHER ORDERED** that Plaintiff may serve Defendant Unknown Father, the father of the Minor Child, E.M.T.F. (DOB: 05/23/2009) by posting on the Superior Court for the District of Columbia's website for a period of twenty-one (21) calendar days and in the Domestic Relations Clerk's Office, starting with the date of this order; and it is

FURTHER ORDERED that if Defendant Unknown Father does not file a responsive pleadings withing twenty-one (21) days after service pursuant to the Rules Governing Domestic Relations Proceedings, Rule 12(a), Plaintiff may file a motion for default and the Court may enter default by order and may convert the next hearing into a default/ex parte hearing to take testimony from Plaintiff and file a final judgment without Defendant Unknown Father's participation, and it is

FURTHER ORDERED, that if Plaintiff is seeking a default judgment, prior to the next scheduling hearing, Plaintiff shall file an Affidavit in Compliance with the Servicemembers Civil Relief Act; and it is

FURTHER ORDERED that a hearing on Plaintiff's Motion is scheduled for **June 4**, **2024**, **at 2:00 p.m**. before Magistrate Judge Julie R. Breslow remotely on WebEx 99. Instructions on how to appear remotely are attached to this order; and it is

SO ORDERED.
